Sue Tongue has been appointed Deputy President of the ALRC until September 1996. At the time of her appointment Sue Tongue was a senior manager with the Human Rights and Equal Opportunity Commission as well as Deputy Chair of the Australian Consumers Council. She combines wide ranging experience in government legal areas, tertiary educational institutions and private legal practice. As an Assistant Secretary with the Department of Social

Security Sue Tongue worked on the child support scheme and equal opportunity issues. Before that she was Ministerial Adviser to the then Attorney-General Senator Gareth Evans. Her consultative experience includes working as Ministerial Nominee on the General Insurance Claims Review Panel and, since 1986, consultant to the Human Rights and Equal Opportunity Commission on sex discrimination. She was a Senior Research Fellow at the Institute for Ethics and Public Policy at Monash University. Before that she was lecturer and tutor in Torts and Introduction to Law at the Queensland Institute of Technology.

Stephen Mason left the Commission in October 1993 to join Blake Dawson Waldron solicitors as Special Counsel in their Sydney office. Until October he had been a full time member of the ALRC. Before his appointment as a full time Commissioner in 1992 he was Secretary and Director of Research of the ALRC from 1986 to 1992; Legislative Counsel 1981 to 1986; and Assistant Legislative Counsel from 1980 to 1981.

Justice Elizabeth Evatt has been appointed a part time member of the Commission to work on the *Equality before the law* reference. Joining her on the *Equality* reference are three new part time Commissioners, **Professors Hilary Charlesworth**, **Regina Graycar** and **Jennifer Morgan**.

Hilary Charlesworth is Professor of Law at the University of Adelaide. She holds a Bachelor of Arts (Hons) and a Bachelor in Laws from the University of Melbourne and a Doctor of Juridical Science from Harvard Law School.

Professor Charlesworth was previously an Associate with the New York law firm of Sullivan and Cromwell and a Human Rights Fellow with the United Nations High Commissioner for Refugees in Geneva. She has been a member or consultant on numerous professional bodies and community organisations including the National Women's Consultative Committee.

Regina Graycar is Associate Professor of Law at the University of New South Wales. She holds a Bachelor in Laws (Hons), University of Adelaide and Masters in Laws, Harvard University.

Professor Graycar has previously been a consultant to the National Committee on Violence Against Women, a policy adviser with the Australian Council of Social Service and a consultant to the New South Wales Law Reform Commission's Accident Compensation Reference and Legal Profession Inquiry. She is co-author of *The Hidden Gender of Law*.

Jennifer Morgan is Associate Professor of Law, University of Melbourne. She holds a Bachelor of Arts (Hons), Sydney University, a Bachelor in Laws, University of New South Wales and a Master in Laws, Yale University.

Professor Morgan was previously a senior lecturer at the Law Faculty of the University of Melbourne, a senior tutor at the Faculty of Law of Monash University and a research officer with the Law Foundation of New South Wales. She has been a consultant or a member of the Legal Service Bulletin Cooperative and the New South Wales Premier's Task Force on domestic Violence. She is co-author of The Hidden Gender of Law and Community Justice Centres: A Report on the NSW Pilot Project.

Brent Fisse was appointed a part time member of the Commission in September 1993. His term expires in August 1994. Brent Fisse has been a Professor of Law at the University of Sydney since 1985. He was Dean of the University of Adelaide Law School and Bicentennial Fellow in Criminal Law and Administration at the University of Pennsylvania. Professor Fisse has published widely and has acted as consultant to companies and law firms on liability control systems and issues of compliance in corporate regulation, including companies and securities offences, trade practices, consumer protection law, confiscation of proceeds of crime and environmental law. He is also a part time member of the New South Wales Law Reform Commission.

Dr Rowena Daw, a lecturer in law at the University of Technology, Sydney, is working as consultant on the *Equality before the law* reference. Dr Daw is coordinating the writing of the interim report which is due in January. She also made a substantial contribution to the Commission's report on *Choice of Law (ALRC 58)*.

Also joining the *Equality* team in December and January is **Ania Wilczynski**. Ania has just returned from Cambridge where she completed her PhD in criminology. She will assisting with the completion of the interim report.

Fresh from being sworn in, **Alexis Brajtman** and **Ursula Armstrong** joined the Commission as research assistants, having spent the first six months of the year at the College of Law. Before that they were at the University of New South Wales completing their BA LLBs. Ms Brajtman is researching *Designs Legislation* and Ms Armstrong is assisting on the *Equality* reference.

Sture Rygaard is on temporary assignment from the University of Copenhagen in Denmark where he is in the final year of his LLM studies. He joined the *Designs* team in July this year and returns to Denmark next February. He had previously worked for three years with the Parliamentary Ombudsman in Denmark.

Maggie Wilson had previously worked as Information Officer at Penrith Family Resource Centre, and before that as Projects Co-ordinator at the Pearl Watson Foundation.

New South Wales Law Reform Commission

Two new legal officers, Mr Bruce Fischer and Ms Saku Akmeemana, commenced in June this year. Mr Fischer is a graduate in Law from the University of NSW and was recently admitted as a solicitor. In his former life he was a professional musician. Ms Akmeemana has degrees in Arts and Law from the University of Sydney. Ex-Chairman of the ALRC appointed to Cambodia Human Rights Post

Justice Michael Kirby CMG has been appointed Special

Representative on Human Rights in Cambodia of the Secretary General of the United Nations. The Secretary General, Dr Boutros Ghali, approved Justice Kirby's appointment on 28 November this year.

It is a part time post, designed to provide information to the Secretary General and, through him, to the United Nations, on progress in the constitutional reforms in Cambodia concerned with observance of human rights.

Justice Kirby is President of the New South Wales Court of Appeal and a former Chairman of the ALRC. He has held a number of international posts in the International Labour Organisation, the Global Commission on AIDS of the World Health Organisation, UNESCO and the OECD. He is also Chairman of the Executive Committee of the International Commission of Jurists in Geneva.

Justice Kirby visited Cambodia in July to take part in the training of their judges. Most of their predecessors were either killed or sent into exile during the Pol Pot regime. He will probably visit Cambodia several times a year.

Access to Justice Advisory Committee

Federal Court
