News from the Deep South

Since last we spoke, the Victorian Society has been hyperactive. Contrary to doctor's advice we have not retired to our (separate) beds with a soothing broth of equal parts water and Scotch whisky; we have burnt candles and cliches at both ends in our efforts to instil a love of computer law in the cold-hearted Victorians.

We marked last year's end with our Annual General Meeting, an event notable for its learning and wassailing. Mr Justice Teague of the Victorian Supreme Court talked on the computerisation in the Court. His entertaining and erudite discussion was unfortunately marred by executive members (a.k.a. The Orangutans) shot-gunning ouzo and cola. Mercifully, Mr Justice Teague saw nothing, and we, sorry I mean they, staggered off into the night.

The hangovers passed early in the New Year, and our first seminar for 1992 focussed on the Circuit Layouts Act. Mr David Webber, a patent attorney with Davies Collison Cave, talked on the Nintendo v Centronics case. Mr Webber was the patent attorney advising Nintendo (the successful applicant) in the case, and showed the assembled throng photographs and other material which made the facts of the case clearer to all. His knowledge of semiconductor circuitry and the Act shows the importance of having good technical advice, married with knowledge of the law.

At the time this goes to press, Mr Julian Burnside QC is scheduled to talk on the Autodesk decision. His comments, and how they correspond with other notables in the field (some of whose comments will appear in both of the next editions of the *Intellectual Property Law Bulletin* and this humble organ) we will report in the next instalment of the Saga of the Deep South.

Shortly thereafter, we have scheduled an, as yet unnamed, speaker on the other *Circuit Layouts Act* case, *Avel* v *Wells*. We'll keep you posted.

New Zealand

1991 was another busy and successful year for the Society in the Land of the Long White Cloud.

Data Privacy featured prominently on the agenda. The Information Privacy Bill which was limited to the public sector was passed in Parliament in December 1991. Peter Scott from the National Library of New Zealand was invited to present key points from his paper on Information Policy in Wellington and Auckland. The paper was sponsored by the Institute of Policy

Studies of Victoria University and the National Library.

The Christchurch branch held a seminar on "Contingency Planning for Law Offices" by Ed Manco from Deloitte Ross Tohmatsu in September 1991 and a seminar on "Information Privacy" in October last year. The speakers for the latter seminar were John Burrows, Professor of Law at Canterbury University, Grant Liddell from the Otago Law School, John Angland from Baynet Systems and Murray Trounson from the Computer Society.

On 12 November 1991, Anthony Wong, the President of the Society presented a paper on the "Legality of Documents on Optical Storage" at the premises of Rudd Watts & Stone in Wellington. He was joined by Bernard Robertson, Law Lecturer at Victoria University who introduced the fundamentals of the rules of evidence. The half day seminar concluded with a paper on "Reform of Documentary Evidence Law" by Loretta Desourdy, Senior Legal Research Officer at the Law Commission.

The Society endorsed the Conference on "Managing the Impact of Information Privacy" which was organised by AIC Conferences at the James Cook Hotel in Wellington on 19 and 20 November. The participants joined the members for end of year drinks at the National Library of New Zealand.

The end of year drinks were held in conjunction with the Society's second legal computer exhibition on 19 November 1991. Ten exhibitors participated in the exhibition.

In March 1992, The Honourable Mr Justice Tompkins spoke on the "Usage of Computers in the Courts" in Wellington. The Christchurch branch is also organising a seminar on "Networking for the Legal Office" in March or April 1992.

The New Zealand Society held its Annual General Meeting on 11 March 1992. To the disappointment of the committee, Anthony Wong gave notice of his intention to resign as President. Anthony has been the moving spirit behind the Society in New Zealand, from the formation of the steering committee in 1987, and his energy and enthusiasm have been major factors in the number and quality of seminars and functions which the Society has conducted.

Gavin Adlam of Rudd Watts & Stone was elected President and there have been a number of other changes to the committee. By the time this newslettter reaches you, all members of the New Zealand Society will have received a report on the AGM and a copy of the Society's accounts for the year.

The new committee is working on a programme for the rest of 1992. The first seminar, on computer contracts and escrow agreements, is proposed for 23 April 1992 in Wellington. Other possible topics under consideration include the legal and business implications of out sourcing, parallel importation and copyright law, computer crime, and issues arising in the valuation of intellectual property and taking security over intellectual property assets.

Imaging Seminar

On Wednesday 18 March, 1992, the Society hosted a seminar on Document Management with Imaging Technology. Three speakers presented very informative talks.

- Brian Varney from Wang Australia gave an overview of the technology;
- David Hubbard from Corporate Systems Planning Pty Ltd gave an overview of how imaging technology is being used in large litigation matters, such as the Rothwells Inquiry and other WA Royal Commissions of inquiry; and
- Don Beer from the WA Land Titles Office showed how all titles are to be stored on optical disc within the next 12 months

enabling the public to order title searches from remote terminals and receive searches by fax. This will enable the LTO to be generally much more efficient, among the most effective in the world!

Software Theft and Piracy

On Wednesday 8 April 1992, the Society hosted a very well attended seminar on Software Theft and Piracy. There were two speakers:

 Doug Ruttan, Director of Business Software Association of Australia spoke about:

the BSAA, who and what it is, why it was formed and its international affiliations;

the extent of illegal software piracy in Australia, the BSAA's campaign against it and how piracy has markedly decreased since the BSAA launched its campaign; and

some of the successful prosecutions.

 David Sigler, solicitor with Clayton Utz, Perth, followed with a commentary and legal perspective on the issue.

Many questions and spirited discussion followed the presentations.

Workshop Introducing lawyers to Computers

The Society has organised for the Perth based company Corporate Systems Education Pty Ltd to conduct workshops to introduce computer-illiterate lawyers to computers. The first workshop in this series was held on Monday 18 March. The session went from 1.30pm to 5.30pm.

Numbers were limited to eight. The first group saw a mixture of legal experience ranging from articled clerks to partners. All who attended found it worthwhile and due to popular demand, further courses are scheduled for early May and the middle of June.
