# **PERIOD OF TEMPORARY TRANSMISSIONS**

The ABA has considered the period for which temporary transmissions should be granted. Temporary transmissions are generally used by aspirant community broadcasters to develop community support and technical and programming expertise leading up to the invitation for

applications for a community broadcasting licence.

The ABA decided to continue with the limit of 28 days in a 12 month period, as was provided for under the now repealed *Broadcasting Act 1942*, for an interim period, pending consultation with inter-

ested parties. It also decided that all groups would be deemed to have zero accumulated test transmission days as of 5 October 1992.

The ABA will further consider the matter after consultation has been completed.
