

BRIEFING NOTES

TEMPORARY PERMIT

The ABA had no grounds to extend HITZ-FM's temporary transmission permit, which expired on Saturday 12 March. HITZ-FM is an aspiring community broadcaster which had been testing across Melbourne since 8 December last year. See p.2

CABLE TV

The ABA has allocated licences for pay TV broadcasting services to Cable Television Services Pty Ltd (CTS). CTS has indicated it intends to deliver pay TV services via Telecom's Laser Cast hybrid cable system to Brisbane, Gold Coast, Sydney, Melbourne, Canberra, Adelaide and Perth. See p.3

PAY TV LITIGATION ENDS

Two legal actions seeking review of the ABA's decision to allocate subscription satellite television licences A and B were dismissed by the concent of all parties on 11 March 1994. See p. 3

SIPHONING INVESTIGATION

The ABA has meet with representatives of sporting bodies and consumer groups before preparing its report to the Minister, due on 26 April. The ABA is investigating which events of national or cultural importance should continue to be available on free-to-air television. See p.3

COMMERCIAL TELEVISION REVENUE CONTINUES TO GROW

Total advertising revenue for commercial television increased by nearly 10 per cent to \$1868.4m in 1992-93, compared with an 8.3 per cent increase in the previous year. See p.9

SNAPSHOT OF AUSTRALIAN AND IMPORTED PROGRAMMING

In 1992, overseas drama programs far outnumbered Australian which made up 9.2 per cent of all Australian programs broadcast in Sydney in the 6 a.m. to midnight period. Overseas drama represents the major category of imported programs, comprising 66.7 per cent of all imported programming in the same time slot.
