ABA discretion

If the ABA is satisfied that it is unlikely that another person is likely to be in a position to operate another service the ABA may give permission to the licensee to operate a second commercial television service in the licence area. That is, in this circumstance it is a matter for the ABA whether permission should be given although the circumstances in which the ABA would decline to grant permission under s.73(2) despite being satisfied of the required unlikelihood may be quite limited.
