

The ABA is proposing to make at least 10 new radio licences available in North Queensland and Far North Queensland in new draft licence area plans.

# New radio services proposed for mortherm Queensland

the ABA is proposing to make at least 21 new radio services available for allocation in North Queensland and Far North Queensland. The regions include the radio markets of Cairns, Atherton, Innisfail, Townsville, Mackay and Charters Towers. In draft licence area plans for radio services, the ABA proposes to make licences available for four new commercial radio services, five new community radio services and 12 new open narrowcasting radio services.

#### **Main planning issues**

While the ABA's proposals would increase the availability of radio services throughout the regions, there is limited spectrum available. This is particularly the case in the Townsville area where the operation of the ABC television service on channel 3 further restricts the availability of FM radio channel.

#### **Commercial radio**

The ABA is proposing to make three new commercial radio

licences available for allocation, one each in Townsville, Mackay and Cairns. This follows interest by potential service providers. If these proposals are taken up, Townsville, Mackay and Cairns would each have three commercial radio services. The ABA is also inviting submissions from potential service providers in relation to a possible fourth commercial radio licence in each of Townsville, Mackay and Cairns.

The ABA granted a second commercial radio licence to the operator of 4GC Charters Towers on 7 May 1996. This service has yet to commence broadcasting.

The ABA is also proposing to decrease the licence area of the existing commercial radio service in Atherton, 4AM. This will make the licensee eligible to apply for a second commercial radio licence under section. 39 of the Broadcasting Services Act.

#### **Community radio**

The ABA has proposed to make one new community radio licence available in each of Cairns, Atherton, Townsville, Mackay and Bowen. Once these licences are issued, residents of Cairns, Townsville and Mackay will have access to two community radio services each.

There is interest in providing two additional community radio services in the Cairns market. However, given available technical capacity in the Cairns market, the ABA considers it is feasible to plan only one additional service for the market.

The ABA is proposing an increase in transmitting power for the existing community radio services in Townsville, 4TTT and 4KIG. The proposal follows submissions from the licensees. A change to a better transmitting site for the existing community radio service 4CRM at Mackay is also proposed following a submission from the licensee.

## Open narrowcasting radio

The draft licence area plans also contain proposals for one AM narrowcasting service in each of Innisfail and Tully, one new FM open narrowcasting service in each of Cairns and Mossman, and two new FΜ open narrowcasting services in Atherton. As well as one high and one low power open narrowcasting services at each of Townsville and Mackay, and one medium power open narrowcasting service at each of Ayr and Ingham.
