

Community radio

The ABA has proposed to make one new community radio licence available for allocation in each of Rockhampton, Gladstone, Yeppoon, Emerald, Maryborough and Hervey Bay as there is interest in providing community radio services in these markets. If a new licence is allocated for Rockhampton, residents of that city will have access to two community radio services.

The ABA is also seeking additional information about making community radio licences available for allocation in Bundaberg and Agnes Water. There is insufficient information about the proposed services in these areas for the ABA to plan a community service in either area at this stage. Given available technical capacity in the markets, the ABA considers it is feasible to plan community radio services in the region.

Open narrowcasting radio

The draft licence area plans also contain proposals for two FM open narrowcasting services in Rockhampton, Bundaberg and Emerald, and one FM open narrowcasting service in each of Gladstone, Yeppoon, Biloela, Moranbah, Saraji, Dysart, Middlemount, Tieri, Blackwater, Clermont and Maryborough.

Public comment

The public is now invited to comment on the suggestions made in the draft radio LAPs. When releasing the draft licence area plans, former ABA Chairman Mr Peter Webb said it is important to understand the ABA's role.

'The ABA's job is to identify vacant radio channels and decide the number and type of new licences to be made available. Then it's for business and the community to take up these opportunities.' others fund extra services. We cannot demand improved reception of existing services,' he said.

'It is also important to note that making any of these services available is dependent on further information being provided to the ABA. The information we are seeking is detailed in the discussion paper and a recently published booklet, *The ABA's General Approach to Planning.*'

The release of draft licence area plans follows wide public consultation by the ABA which held public meetings in the region in June 1995. The ABA recognises that the information currently available to it may be dated, and is seeking extra information from interested parties relating to the specific markets being planned. While the ABA can contact parties who have previously expressed an interest, it is also interested in hearing from any other interested parties who have not been
