

The ABA has auctioned seven commercial radio licences and nine transmitter licences to provide open narrowcasting services.

ABA radio auctions raise more than \$9 million

n 20 November the conducted auction-style licence allocation exercises for seven commercial radio licences and nine transmitter licences for open narrowcasting services. A total of \$9 193 000 was bid at the auctions.

Full payment for the commercial radio broadcasting licences must be made between 5 and 7 January 1998. Full payment for the transmitter licences for open narrowcasting services was made on 21 November, the day following the auction. The ABA will issue the licences as soon as possible after full payment is received.

If a successful applicant fails to meet any of the requirements of the price-based allocation systems or relevant legislation, the licence will not be issued to the applicant. The ABA may then re-offer the licence for allocation.

The ABA has approved a temporary breach of the ownership and control rules of the Broadcasting Services Act by Radio Ballarat Pty Ltd. Radio Ballarat Pty Ltd, the successful bidder for the new Ballarat licence, already holds two licences in the Ballarat radio market (the maximum allowed). It must divest one of the licences within six months of the ABA's permission). being allocated the new licence.

Commercial broadcasting licensees must begin a service within one year of being allocated the licence (or within a longer period with the ABA's permission). The holder of a transmitter licence for open narrowcasting services must commence within six months of the licence being issued (or within a longer period with 3
