'Cable television has launched this month in Perth, increasing the range of television choices for viewers. But what contribution should the pay TV industry make to developing and reflecting a sense of Australian identity, character and cultural diversity? This is a key issue being considered by the ABA in its investigation into Australian content requirements for pay TV,' said Ms Lesley Osborne, ABA Manager Standards.

Ms Osborne was speaking in Fremantle at the 'Small Screen: Big Picture' television conference—hosted by ScreenWest, 21 to 23 February 1997

This year's ScreenWest conference was subtitled 'Programming for a Global Village' and focussed on issues facing the screen industry in the light of government reviews of funding and other mechanisms for industry support. Challenges and opportunities presented by changes in the international entertainment environment were also discussed with input from overseas speakers such as Anna Home, Head of Children's Programmes at the BBC.

The ABA participated in a panel discussion on the regulation of Australian content on pay TV debating the pros and cons, experience with the current requirement for expenditure on new Australian drama, and the views of submitters to the ABA's investigation.
