The ABA has finalised licence area plans making FM channels available for new community and open narrowcasting radio services in Bathurst, Lithgow and Parkes.

New radio services for Bathurst, Lithgow and Parkes

The ABA has made FM channels available for new community and open narrowcasting radio services in Bathurst, Lithgow and Parkes, New South Wales. The decisions are contained in the ABA's final licence area plans for radio in

Bathurst, Lithgow and Parkes. 'The ABA can now move to allocate licences for the new services it has decided to make available. This marks the beginning of a new stage in radio planning for the more populated areas of New South Wales. The ABA will be announcing further new services to be made available in other areas of Central NSW over the coming weeks,' said Peter Webb, ABA Chairman.

In Bathurst, FM channels have been made available for a new community radio service and an open narrowcasting radio service. Two FM channels have been reserved for new national broadcasting services.

In Lithgow, FM channels have been made available for a new community radio service and an open narrowcasting service.


'The licence for the community radio service in Lithgow will not be available for allocation for at least two years. This will give existing aspirant groups time to consolidate and new aspirant groups the opportunity to emerge,' said Mr Webb.

Channels have been made available for new open narrowcasting services in Parkes and Condobolin and a new national radio service in Condobolin.

The ABA has decided to allow 2LVR, the existing community radio service in Forbes/Parkes, to increase its operating power and to extend its licence area to match that of the commercial radio services 2PK and 2ROK Parkes. The ABA has also provided an FM channel for transmission of the 2LVR service at Condobolin.

The decision to make the community services available follows interest expressed by aspirant community radio groups. Any new community radio licences will be made available by means of a meritbased allocation process. The ABA expects to call for applications for the Bathurst licence from interested groups in the next few months.

The decision to make the open narrowcasting services available follows interest expressed by aspirant open narrowcasting operators. The licences for these services will be issued via an auction, expected to be held before the end of the year.



Commercial radio

No additional commercial radio licences will be made available in Bathurst, Lithgow or Parkes.

The ABA allocated second commercial radio licences to the licensees of 2BS Bathurst, 2LT Lithgow and 2PK Parkes in February and March 1996. The new Bathurst service, on FM 99.3 MHz, commenced in December 1996. Neither the second Lithgow service (2ICE on 95.3 MHz) nor the second service in Parkes (2ROK on 95.5 MHz) have yet commenced.

Community radio

Bathurst Christian Broadcasters, 2MBS-FM and 2RPH (the latter two both based in Sydney) have expressed interest in providing a community radio service in Bathurst.

Lithgow Community Broad-

casters, 2MBS-FM and 2RPH have expressed interest in providing a community radio service in Lithgow.

The ABA has decided to delay allocation of the Lithgow community radio licence for at least two years. Any new community radio licences will be made available by means of a merit-based allocation process.

Open narrowcasting

Bathurst Broadcasters Pty Ltd (the licensee of commercial radio services 2BS and 2BXS Bathurst), 2KY Sport and Talk and Western Visitor Radio (based in Dubbo) have all expressed interest in providing open narrowcasting radio services in Bathurst and Lithgow.

2KY Sport and Talk and Western Visitor Radio have expressed interest in providing an open narrowcasting D



Condobolin.

All the licences made available for open narrowcasting services will be allocated via a price-based allocation system.

ABA planning process

The release of licence area plans is stage three of the planning process. The first stage was completed in September 1993 with the release of the ABA's priorities for plan-
