

The ABA has allocated nine new community radio licences: five in New South Wales, three in Queensland and one in the Northern Territory.

## **Community radio licences**

I new community radio licences: five in New South David Flint, ABA Chairman. Wales, four in Oueensland and one in the Northern Terri-

The licensees have 12 months to start the new services.

The ABA has allocated these licences after consulting with the people of the local community to seek their views on what additional broadcasting services were needed in their area

The ABA received two applications for the licence in Taree: from Mid North Coast Indigenous Broadcasters Association Aboriginal Corporation, and from Manning Great Lakes Christian Broadcasters Inc. (Radio Rhema).

'This was a difficult decision between the two applicants,

The ABA has allocated ten each of whom had different strengths,' said Professor

'Although the decision will be disappointing for Manning Great Lakes Christian Broadcasters, the ABA made every effort to fully consider the claims of the two applicants.'

'The ABA will seek to ensure that programming catering for the needs of those in the Christian community will be provided,' said Professor David Flint, ABA Chairman. 'The ABA has commenced negotiations with Mid North Coast Indigenous Broadcasters, seeking a binding commitment that it will enable the provision of at least two days a week of programming catering to the needs of the Christian community in Taree on its service.'

## ABA decides not to allocate licence in Narrabri

The ABA sought applications for the licence in April 1999. There were two applicants: Narrabri Shire Community Radio Inc. and Kaputar FM Community Radio Inc. Both applicants stated that they represented the general community of Narrabri.

'The ABA decided not to allocate the licence because of its concerns about the ability of both applicants to provide a service that will meet the needs of the general community of Narrabri,' sald ABA Chairman Professor David

The ABA also considered the applicants' capacity to provide their proposed services and the nature and diversity of other broadcasting services in the area.'
