Licences will be issued under a price-based allocation system developed by the ABA. Under the system, if there is more than one applicant for a licence an auction-style licence allocation exercise will be held at which the licence will be issued to the highest bidder. If there is only one application for a licence at the close of applications, the licence will be issued to the applicant for the reserve price.

ABA invites applications for commercial radio licences

The ABA invites applications for three new commercial radio licences. One licence is in Coffs Harbour, one in Kempsey/Port Macquarie, New South Wales and one in Toowoomba/Warwick, Queensland. The ABA has set a reserve price of \$100 000 for each of the licences.

Applications for the licences will close at midnight on Friday 16 April 1999.

Companies interested in applying for a licence must purchase the information package: *Price-based Allocation of Commercial Broadcasting Licences*, available from the ABA, price \$50.

Applications invited for open narrowcasting licences

The ABA invites applications for 24 new open narrowcasting radio services to serve areas in New South Wales and Queensland.

The areas in which the licences are available are: Armidale, Barham, Coffs Harbour, Gloucester, Grafton, Gunnedah, Kempsey, Muswellbrook, Murrurundi, Port Macquarie, Tamworth, Taree and Walcha in New South Wales; and Cairns, Dalby, Emerald, Innisfail, Kingaroy (2 licences), Moranbah, Stanthorpe, Toowoomba (3 licences) and Warwick in Queensland.

The ABA has set a reserve price of \$4000 for each of the licences. Applications for the licences will close at 4.00 p.m. on 16 April.
