ABA to hold public hearing to assist in allocating three Sydney-wide community radio licences

The ABA will conduct a public hearing to assist it in allocating three new Sydney-wide community radio licences. The hearing will be held in the Marconi Room at the Sydney Town Hall from Monday 14 August 2000.

'The hearing will assist the ABA in deciding the relative merits of the applicants. It is also a good opportunity for the applicants to highlight particular aspects of their case to the ABA in person,' said Professor Flint.

All applicants that meet the statutory criteria will be eligible to appear at the hearing.

The ABA invited applications for three Sydney-wide and four suburban community radio licences in February.

The three Sydney-wide licences will be allocated first, after the hearing. The four

suburban community licences will be allocated afterwards in separate processes.

In making its decisions, the ABA will consider all the information and submissions provided during the allocation process.

Further details of the hearing will be advised by letter to all applicants, and by public notice later this year.

New non-broadcasting services bands commercial radio licence

The ABA has allocated a new commercial radio broadcasting licence to cover an area of Queensland south of latitude 16° but excluding the existing Charleville commercial radio licence area.

The licence has been allocated to Pinecam Pty Ltd.

Pinecam Pty Ltd must commence its service within 12 months of being allocated the licence, or within a longer period as approved by the ABA. The licensee may not use the broadcasting services bands to deliver its service.
