public hearing to assist it in allocating three new Melbourne-wide community radio licences and a Melbourne City community radio licence. The hearing will be held in the Old Council Chambers (formerly the Reception Room) at the Melbourne Town Hall from Monday 13 August to Friday 17 August 2001.

'The hearing will assist the ABA in deciding the relative merits of the applicants. It is also a good opportunity for the applicants to argue their application to the ABA in person,' said ABA Chairman, Professor David Flint.

Anyone making a submission in relation to the hearing and allocation of licences should be aware that the ABA might place these materials on a public file, on the ABA's web site, provide copies to applicants, and may require them to participate in the hearing process.

Community broadcasting

Only non-profit community broadcasting organisations, which represent a community interest, are eligible for the allocation of a community broadcasting licence.

The ABA's licence allocation system applies to services using radiofrequency spectrum in the broadcasting services bands (e.g. FM radio), not to community services using cable, satellite or other means of delivery.

The ABA will assess all applications on the basis of the merits of the applicants and their proposed services and on the comparative merits of competing applications, having regard to the Broadcasting Services Act 1992.
