No applications received for Lord Howe Island community radio licence

The ABA has decided not to proceed with the allocation of a community radio broadcasting licence for Lord Howe Island at this time.

The ABA sought applications for the licence on 13 September 2002. The closing date for applications was 10 October 2002. No applications had been received by the closing date.

Aspirant community broadcaster Lord Howe Island Radio Station Association Incorporated has been broadcasting under a temporary community broadcasting licence since October 2001, however it advised the ABA that it would not be applying for the permanent licence. No other groups or individuals contacted the ABA expressing an interest in applying for the licence.

'The ABA may readvertise the licence at some time in the future. The ABA hopes that during the intervening period links can be formed between the current aspirant group and the broader Lord Howe Island community to provide a more extensive service,' said Professor Flint.

Any other groups who are interested in providing a community radio broadcasting service will be able to broadcast under a temporary community broadcast licence, sharing the one frequency (100.1 MHz) available in the area for this purpose.

Extensions of time for:

6AR and 6NR to convert to FM

The ABA has extended the time period within which the Perth community radio services 6AR and 6NR are required to convert from AM to FM. The extension is until 23 October 2003.

The ABA determined the Perth licence area plan on 12 October 2001. In the plan, the ABA made channel capacity available for both 6AR and 6NR to change their broadcasting frequencies. 6NR is to move from 927 kHz to 100.1 MHz and 6AR is to move from 1170 kHz to 100.9 MHz.

While 6AR and 6NR have begun the process of converting to FM, both have indicated last minute difficulties in meeting the requirement to convert by the due date (23 October 2002) and requested an extension of time. 6NR is known to be switching frequencies in the near future, but this will be from a temporary transmitter site.

Change of frequency in Mt Gambier

The ABA is proposing to extend the time period within which the Mt Gambier community radio service 5GTR is required to change its operating frequency.

The ABA determined the Mt Gambier licence area plan in December 2001, deciding to reserve channel capacity for one additional national radio service on 105.7 MHz. To make the additional service available, the 5GTR community radio service was required to change frequency, from 105.7 MHz to 100.1 MHz by 18 December 2002.

In response to recent advice from the ABC that it would not be ready to commence operating the additional service in Mt Gambier until mid 2004, the ABA is now proposing to allow 5GTR until 31 December 2003 to change its frequency.

The closing date for comment was 28 October 2002.
