ABA decides not to allocate community radio licence in Blacktown

The ABA has decided not to allocate a community radio broadcasting licence in Blacktown at this time.

The ABA sought applications for the licence in February 2000. Three groups applied, Blacktown City Community Radio SWR-FM Association Incorporated (SWR-FM), Voice of Charity Limited, and Western Community-Radio Association Incorporated (West FM). Both SWR-FM and West FM claim to serve the general community of the Blacktown licence area while Voice of Charity claim to serve the Christian community.

'After giving careful consideration to the criteria laid down in the legislation and the information provided by all applicants, the ABA has decided in this case not to allocate the licence,' said Professor David Flint, ABA Chairman.

The ABA finds that none of the applicants were able to satisfy the ABA that they could provide a broadcasting service that would adequately serve the particular demographics of the Blacktown licence area. The ABA encourages the applicants to work together to create an open and well managed coalition that would accommodate both the high number of young people and the vibrant

ethnic community in the licence area,' said Professor Flint.

'At some time in the future the matter can be reconsidered and then the licence can be readvertised. During the intervening period it may be that cooperative arrangements can be formed between the groups,' he said.

Until such time as the ABA reviews the temporary licence services and reconsiders a permanent allocation, the channel set aside for this licence (99.9 MHz) will continue to be made available for temporary community broadcasting. All groups will be able to broadcast under temporary community broadcasting licences, sharing the one frequency.

The Blacktown licence area contains almost twice the population of Blacktown itself, and includes parts of Fairfield as well as Eastern Creek, Edensor Park, Horsley Park, Plumpton and Riverstone. At Census 1996 the licence area population was 494,474.

ABC and SBS television and the three commercial television services broadcast in the Blacktown licence area. Radio services include the all the ABC AM and FM services, SBS services 2SBS FM and 2EA, all the Sydney-wide commercial radio services and five Sydney-wide community radio services, 2CBA, 2SER, 2MBS, 2RPH and 2000 FM.
