Extension proposed for 5GTR Mt Gambier frequency change

The ABA is proposing to grant the community radio service 5GTR Mt Gambier an extension of time, until 31 December 2004, to change its operating frequency from 105.7 MHz to 100.1 MHz.

South East Access Community Radio (5GTR) was allocated a permanent community radio licence, on 19 August 1998, to serve Mt Gambier on 105.7 MHz with a maximum ERP of 500W (omnidirectional).

The licence area plan for Mt Gambier determined that 5GTR move to an alternative frequency (101.1 MHz) before 18 December 2002, in order to make channel capacity available for an additional high power national radio service on 105.7 MHz.

The ABC has advised the ABA that it would not be ready to commence operating the additional service by 31 December 2003 and that it would give the ABA at least 12 months notice before commencing the service. This delay on the part of the ABC has meant that 5GTR has been given a longer timeframe to plan for the change in frequency and to prepare for the costs of the change. 5GTR has expressed interest in extending the date of the frequency change to more closely mirror that of the ABC commencement date.
