### Proposed licence area for a new digital television service in Mildura/Sunraysia

Mildura Digital Television Pty Ltd, a joint venture company of WIN Television Mildura Pty Ltd and Prime Television (Victoria) Pty Ltd, has expressed its interest in providing a third commercial television service in the Mildura/Sunraysia licence area.

Mildura Digital Television Pty Ltd has 12 months to apply for the additional commercial television licence from the designated time of 19 January 2004 set by the ABA.

Before a third commercial television licence could be allocated, the ABA had first to designate the licence area for the service. The ABA released a draft variation to the Mildura/Sunraysia television licence area plan proposing that the licence area for the third service be identical to the current licence areas of STV Mildura/Sunraysia (WIN) and PTV Mildura/Sunraysia (Prime).

### Open narrowcast radio service proposed for Perisher

The ABA is proposing to make channel capacity available for an open narrowcasting radio service in Perisher, New South Wales.

The service is proposed to operate on FM 94.3 MHz, with a coverage radius of 20 kilometres.

The proposal is contained in draft variation to the Cooma licence area plan. ☞
