



## Proposed amendments to Digital Terrestrial Television Broadcasting Handbook

The ABA is seeking comment on proposed amendments to its *Digital Terrestrial Television Broadcasting Handbook*, which was first issued in July 1999.

The amendments are detailed in a draft revision of the handbook. The closing date for submissions is 5 pm, Friday 22 October 2004.

The *DTTB Handbook* gives the general technical assumptions to which the ABA will have regard when preparing digital channel plans under the Commercial Television Conversion and National Television Conversion schemes. It also explains the technical planning processes involved in planning of new digital television services and converting existing analog television services.

Under section 6(1) of the Commercial and National Television Conversion schemes, the ABA is required to publish a document explaining the technical assumptions to which it will have regard when considering whether the transmission of a commercial or national television broadcasting service in standard definition television digital mode will achieve the same level of coverage and potential reception quality as is achieved by the transmission of that service in analog mode. The ABA may also publish an explanation of other general technical assumptions to which it will have regard when preparing a digital channel plan under the conversion schemes.
