



- to make FM channel capacity available for a new community radio service in Wodonga and to make additional channel capacity available for the Walwa/Jingellic community radio service at Tumbarumba and Corryong on 107.7 MHz and 98.9 MHz respectively. The ABA proposes to extend the Walwa/Jingellic community radio service licence area to include Tumbarumba, Corryong and Tintaldra
- to increase the operating power of the ABC radio service, 3RN at Albury to allow better coverage to the outer parts of its service area. The increased power will be subject to successful test transmissions to ensure no interference is caused to 2ST Nowra and 3HA Hamilton.

The ABA is not proposing to make any new national services available in the Upper Murray. In 2002, the ABC sought from the then Minister of Communications, Information Technology and the Arts reservation of channel capacity for additional national services across Australia, including Upper Murray. The ABA has found that there is no suitable spectrum available in the Upper Murray region that could be used for a high power FM national service.
