ABA invites applications for commercial radio licences in Sydney and Brisbane

The Australian Broadcasting Authority has invited applications for a new commercial radio broadcasting licence to serve Sydney on 95.3 MHz and one to serve Brisbane on 106.9 MHz.

The application period will close at midnight on Monday, 22 March 2004. Companies interested in applying for the licences must purchase an Information Package titled *Price-based Allocation of Commercial Broadcasting Licence* from the ABA. The cost of the package is \$50.00 (inclusive of GST).

The Information Package explains how to apply for a licence, provides technical specifications about the service for which the licence is available, and contains copies of the forms to be completed by intending applicants. The package also contains details of the price-based system determined by the ABA, the conditions that apply to commercial broadcasting licences and other information relating to the licence area of the licence being offered for allocation.

The ABA will publish the names of registered bidders and their ACN/ABN numbers in a news release prior to auction.

The reserve price for each licence is \$1 million.

New Radio Services for Coober Pedy and Roxby Downs

The Australian Broadcasting Authority has decided to make frequencies available for new permanent community radio services in Coober Pedy and Roxby Downs, South Australia.

The Coober Pedy community radio service will operate on 104.5 MHz. The Roxby Downs community radio service will operate on 105.5 MHz.

The ABA's decisions are contained in its new licence area plans for community radio in Coober Pedy and Roxby Downs.

"The ABA has taken into account the views of those who made submissions before deciding on the most beneficial mix of new services to be made available in the Coober Pedy and Roxby Downs areas," said Professor David Flint, ABA Chairman.

Dusty Radio have expressed interest in providing a permanent community radio service in Coober Pedy. Dusty Radio has been operating under a temporary community broadcasting licence (TCBL) since 1999.

Channel capacity is made available as follows:

• 104.5 MHz from Coober Pedy Area School SA, with a maximum effective radiated power (ERP) of 100 W (omni-directional with vertical polarisation).

ABA proposes additional community radio service in Kingaroy, Qld

The Australian Broadcasting Authority has sought public comment on a proposal to increase the availability of radio services in the Kingaroy area.

The proposal was contained in an explanatory paper and draft variation to the Kingaroy licence area plan. The ABA determined the Kingaroy licence area plan in October 1998.

Since July 2002, the Yarraman and District Historical Society Inc (YDHS) has been operating on a temporary community broadcasting licence, using the frequency 99.7 MHz. YDHS has expressed interest in obtaining a permanent community radio licence to serve the town of Yarraman.

The ABA determined the licence area populations of the Kingaroy commercial and community radio broadcasting licences, using 1996 Census figures, in 1998. It is proposed that the licence areas now be redefined using 2001 Census figures.
