



New telecommunications consumer action network

The Australian Government has announced the formation of a new peak telecommunications consumer body, the Australian Communications Consumer Action Network (ACCAN) and its founding board.

Senator Stephen Conroy, Minister for Broadband, Communications and the Digital Economy, said the development of ACCAN was '... an important step in the process towards a stronger unified consumer voice. Strong and effective consumer representation is paramount for a vibrant and competitive telecommunications market'.
