

RadComms09:

ACMA and industry share perspectives

RadComms09, ACMA's third annual spectrum management conference held on 29 and 30 April 2009 at the Australian National Maritime Museum, Sydney, attracted over 210 delegates, including representatives from federal, state and local government, carriers and service providers, satellite operators, broadcasters, equipment manufacturers and retailers. Also in attendance were representatives of regional development boards, community organisations and internet service providers.

Conference presentations focused on contemporary topics in radiofrequency spectrum management. ACMA projects covered were:

- opportunity cost pricing
- technical frameworks
- the 400 MHz band
- digital switchover
- release of the 3.6 GHz band.

More than two-thirds of the presentations at RadComms09 were made by industry, consistent with ACMA Chair, Chris Chapman's intention that 'ACMA continues to seek a balance between government and industry perspectives, and we are looking for industry to take the opportunity

to present on issues rather than just having the regulator run the agenda'.

A welcome reception on the first night of the conference proved to be an effective informal networking opportunity for delegates and ACMA staff. The conclusion of each day featured a Q&A panel session, which generated a high level of audience participation and robust discussion on topical spectrum matters. Other conference highlights included presentations on digital radio and the Australian Square Kilometre Array Pathfinder project.

The theme of the conference was 'foundations for the future'. This was highlighted in Mr Chapman's address 'Disaster, triumph, evolution and innovation: Important lessons from the history of radiocommunications', which offered a glimpse into ACMA's willingness to learn from the past, embrace innovation and take a lead from industry triumphs to ensure the partnership of government and industry will secure for Australia the best outcome possible for our radiofrequency

Senator the Hon. Stephen Conroy, Minister for Broadband, Communications and the Digital

Economy, addressed the conference on the first day. The Minister highlighted, among other things, the importance of the National Broadband Network and the role it will play in the future of Australia, affirming that 'taking action today to create the foundations of our future wireless and fixed communications sectors, will help deliver better outcomes for industry, business and consumers in the years to come'.

The Minister also made special mention of other ACMA projects: 'I'm particularly pleased with the progress the Australian Communications and Media Authority has made in relation to the 3.6 GHz and 400 MHz bands.'

The conference fulfilled its aim of being a valuable opportunity for ACMA to consult and explore with industry a broad range of spectrum planning issues.
