## AUSTRALIAN CRIME PREVENTION COUNCIL

The Council since 1960 has been engaged in assisting and promoting the work of crime prevention, correction and the after-care of offenders — co-ordinating the activities of persons and organisations interested in such work — providing a forum for the free discussion of all matters of interest among those concerned.

The Council holds a conference every two years to focus attention on a particular aspect of crime prevention. This year Tasmania is the host.

## CONFERENCE OBJECTIVES

The 1979 Conference will pay particular attention to long term crime prevention strategies particularly in relation to:

- Urban planning and development;
- Education policies;
- Preventative Police work at a community level.

In all areas there will be emphasis on community and volunteer involvement in these strategies.

The State Branch of the Australian Crime Prevention Council is responsible for the planning of this Conference.

They hope that as a result of the papers that are delivered and the discussion that will follow, delegates will have opportunities to familiarise themselves with innovative approaches to long-term crime prevention.

## CONFERENCE FRAMEWORK

Plenary sessions, working groups and opportunities for informal discussion have been planned in such a way as to meet the diverse interests of Conference participants.

## CONFERENCE PROGRAMME

The Programme has been developed around four general themes:

- Urban Planning and Development
- Education Policies
- Police in the Community
- Role of Volunteers

There will also be alternative and concurrent sessions of particular interest to those involved with:

- Juvenile Offenders
- Sentencing and the Administration of criminal justice
- After care of prisoners
- Law Reform

Speakers for this Conference will be drawn from a wide range of disciplines and will be listed in the Conference Programme.
