CORRESPONDENCE:

During the period under review all correspondence was dealt with both inward and outward.

SEMINARS:

One (1) seminar was held during the past year. It proved very successful. This seminar dealt with "Drugs and Alcohol - Their Danger to You". It was held on the 31 March, 1980. The convenor in this instance was Mr. Peter Johnson, M.P., and the venue was the Australian Government Centre, Ann Street, Brisbane. Considerable publicity was attracted to this exercise. It was opened by the Minister for Mines, Energy and Police, the Honourable R.E. Camm. This seminar was a first in that the audience comprised of 103 Grade 12 students from various schools within the Metropolitan area.

Guest speakers were, Dr. D. Wilson, Detective Senior Constable G. Cousins of the Drug Squad and a person who had previously had a drug problem but had since been rehabilitated. The Rapporteur for this seminar was the distinguished barrister, Mr. Cedric Hampson, Q.C.

An indication of the success of this seminar was that a similar programme has now been planned and will indeed be held in the Nambour District on the 16 July 1980.

Of interest, during the past year serious endeavours were made to conduct a seminar on Shop Stealing but this plan was confronted with many difficulties whilst the branch felt the need for a seminar in this connection was difficult to obtain support from outside sources.

"Forum", the Australian Crime Prevention Council Quarterly Journal continued to be published during the past year with articles of great interest and high quality. This reflects greatly on the dedication of the Executive Director, Mr. J. Purcell.
