N.S.W. BRANCH SECRETARY'S BRANCH REPORT, 1979/1980

Fellow Members,

The year under review has been a year of consolidation and progress.

In brief, membership, especially organisational membership, has continued to increase, although the Branch only represents 12% of the Australian Crime Prevention Council total membership of 500. The winding up of administrative and surplus Reports forwarded to the National Secretariat. The Branch was effectively represented at the Tenth National Conference held in Hobart last August, 1979. It also presented an important and major Crime Prevention Seminar on the "Police and Citizens", and is holding a Seminar on the After Care Agencies next month. Plans were developed for a major Comparative Study of the Fear of Crime in conjunction with the Australian Institute of Criminology. The Branch held regular meetings and continued to play an important role in the management of the Australian Crime Prevention Council and its pursuit of justice.

Although the 6th U.N. Congress on the Prevention of Crime and the Treatment of Offenders will not now be held

in Australia this year as originally planned, the Branch obtained and distributed to members a limited number of the five (5) Australian Discussion Papers on Topics to be delivered at the Congress. It has also recommended to the National Executive of A.C.P.C. that the National President or his nominee (funded by the Federal Government) should represent A.C.P.C. at the Congress. This recommendation was adopted by the National Executive. The Branch has further resolved to support an International Commission of Jurists Resolution on Non-Institutional Sanctions. The lengthy Resolution was considered by a Committee under the Chairmanship of Miss T. Delanty and its Report was accepted with minor amendments on the 19th June, 1980.

The Branch also submitted a Resolution which was carried at the Tenth National Conference of A.C.P.C., viz. that no person in custody should be disadvantaged before conviction in the light of the presumption of innocence. All persons in Custody before Conviction should be eligible for special benefits under the Social Services Act regardless of marital status, dependents or commitments. This Resolution has received further general support from the National Executive and from the greater majority of State and Territory Branches. Advice has been received that Special Benefits on written request may

be paid to dependents.

A Resolution to the Congress by Branch delegates, Mr. A.J. Restuccia and Mrs. M. North, for the Council to continue to encourage education authorities to allow instruction on the criminal justice system in all schools at both primary and secondary levels received unanimous support at the Congress and active support from Branches subsequently.

A recent recommendation for the promotion of greater communication between State and Territory Branches was

accepted by the National Executive.

The National Executive has also resolved that after consideration, the National Secretariat should remain located at Broadbeach, Queensland. Articles are invited for the interesting A.C.P.C. quarterly Journal "Forum".

The Tenth A.C.P.C. National Conference was held successfully in Hobart, Tasmania, from 13-17th August, 1979, with "The Community and Crime Prevention" as its theme. Our State Branch was well represented with Mr. F.D. Hayes (Senior Vice President), Mr. C. Cunliffe-Jones (newly-elected Treasurer), Insp. R. Rolles, Mr. A. Webster, Dr. J. Sutton, Brigadier G. Dickey and the Newcastle Youth Service being in attendance with the Branch delegates - Mrs. M. North and Mr. A. Restuccia. Topics extended to the Social Conditions of cities, urban planning, education, the police, planning and volunteersim. The Resolutions in each category were referred to the National Executive for consideration.

The major project for the coming year would appear to be the comparative "Study of the Fear of Crime", in which each State Branch is co-operating with the Institute of Criminology to conduct a survey on the fear of crime present in the community. Volunteers from members to assist in this project have been invited. Volunteers will be required in the near future when final details are available.

A most informative Seminar on "After-Care Agencies" under Mr. R. O'Brien as Committee Convener will be held on 27th August, 1980, at the State Office Block Theatrette. A cross-section of the types of services available and their experiences will be offered by the speakers. The most recently completed Seminar on "Crime Prevention: Police & Citizens" was strongly supported with the State Theatrette being crowded. The guest speakers were Det. Sgt. J. Kelly, Policewoman Sen. Const. I.S. Juergens, Det. Sgt. T. Lowe and Mr. L.N. O'Neill, a N.S.W. School Principal.

The Branch holds its Seminars to supplement, not compete, with the four (4) Seminars organised annually by the Sydney University Institute of Criminology Seminars which this Branch has always supported and which it commends to members. The Branch under Mr. R. Purvis, Q.C., is currently considering any follow-up action which might be appropriate arising from the Institute's "Delay in Criminal Proceedings" Seminar held earlier this year.

On 4th December, 1979, the Branch held a most enjoyable

Christmas Cocktail party for members.

Planning by the Crime Prevention Week Committee under Mr. J. Parnell, S.M., has been severely disrupted by the serious illness of one of its members, Mr. W. Pegley, as well as the anticipated financial outlay required to present an effective program.

Following the adoption of a new Constitution for A.C.P.C., a review of the State Branch Constitution has become necessary. A committee under Mrs. M. North is undertaking that

review

On the recommendation of the Secretary, a Committee member, Mr. R. O'Brien, was also appointed Assistant Secretary to the Branch. The Secretary hopes that this position might be incorporated into our revised Constitution.

The Executive held nine meetings last year to which Branch members were invited. The presence and contribution of

non Executive members was particularly welcomed.

Arrangements have been completed for the historical records of the Branch to be located with the N.S.W. Bureau of Crime Statistics and Research – a gesture much appreciated.

Appreciation is also expressly due to our Patron, the Hon. F.D. Walker, L.L.M., M.P., Attorney General for N.S.W., Mr. T. Haines, Under-Secretary of the Dept. of the Attorney General and of Justice, and Mr. M. Bennett, a senior administrative officer of the same Department, for their assistance and support.

I also express the personal appreciation of the President, Mr. Justice J.A. Lee and myself for the help and contribution received from the Executive members.

There is little doubt that A.C.P.C. in N.S.W. is progressing. Its progress is not spectacular - it never will be spectacular. For the role of A.C.P.C. is essentially a co-ordinating service, an aid and a channel to those many varied members - organisations, agencies or concerned citizens who are already active in the field of crime prevention and the treatment of offen-

By performing its function in conjunction with its members, both individual and representative, it is hoped that citizens will be happier and our society less tense.
