Meetings of the Committee

Meetings of the Executive Committee were held during the year at regular monthly intervals at the Commonwealth Government Centre and later at Police Headquarters, Makerston Street, Brisbane. I thank the members responsible for the use of these venues.

Correspondence

All inward and outward correspondence for the period was dealt with expeditiously.

Seminars

Two (2) seminars were held during the year, entitled "Drugs and Alcohol — Their Danger To You". These seminars were held at the Q.P.C.Y.W.A. Club, Nambour and the Noosa and District State High School.

The Nambour seminar was attended by approximately 240 students from the areas of Gympie, Nambour and Caloundra. Only one school was involved in the Cooroy seminar with a total of 160 students participating from grades 11 and 12.

Both seminars presented the problem of drugs and alcohol to high school students. They were well received and clearly indicate a desire for students to be more fully informed on these matters.

A number of people, both within and outside the Branch gave of their valuable time to make these seminars a success. Their efforts are recorded with sincere appreciation.

Considerable progress has been made towards organising a similar seminar on the Gold Coast, and it is anticipated this seminar will be held shortly.

During the year discussions have taken place with the Australian-Japan Association in an endeavour to hold a seminar on crime prevention, focusing on Tokyo and Brisbane. As an initial step, Mr W. Clifford, Director of the Australian Institute of Criminology attended a meeting of the Association as a Guest Speaker and further talks were held with the Association. Mr Clifford has also attended a meeting of the Committee and correspondence has been exchanged with the Australian Institute of Criminology with a view to holding a three (3) day symposium on Crime Prevention Planning in selected areas of the City of Brisbane.

Some of the members of the Executive have accepted invitations as Guest Speakers for various organisations. These help to publicize the work of the Branch and are to be encouraged.

Meeting of the National Executive — Melbourne

The Executive Meeting was attended by the State Representative, Mr Lane, the Vice-President of the National Executive, Mr Johnson (Deputy Chairman, Queensland Branch) and Mrs A.A. Campbell. His Honour, Mr Justice Grubb presided over the meeting.
