NEW SOUTH WALES BRANCH SECRETARY'S BRANCH REPORT 1980/81

Fellow Members,

The year under review has been a year of fluctuation.

In brief, membership has continued to rise stadily, a very informative and successful Seminar on After Care of Offenders was held and a consideration of the parole system as it affects migrant offenders was initiated. The Executive Committee met regularly with Committee members consistent in their attendance.

The year presented its disappointments with only one Seminar being held — a most unusual situation, and our projected major activity being delayed. This project was the Comparative Study of the Fear of Crime with Japan proposed by the Australian Institute of Criminolohy. Envisaged as the major project for the year under review it has been delayed because of methodology problems. It is hoped the Institute will resolve the difficulties in the near future so that this worthwhile study can be undertaken.

The Branch held one Seminar — the very successful Seminar on the "After Care of Offenders: Community Alternatives", which was presented on the 27th August, 1980 in the State Office Block Theatrette, Sydney. The guest speakers were Mr. R.G. O'Brien, Managing Secretary, Prisoners Aid Association, Miss Sandra Wilson, Administrator of Guthrie House, Mr. A. Roux, Administrator of Glebe House, Mr. B. Fisher, Society of St. Vincent de Paul, and Mr. F.D. Hayes, Director School of Social Work, Milperra College of Advanced Education, and Commissioner (part time), N.S.W. Corrective Services Commission. The care of offenders after release from custody was discussed widely and perceptively by both speakers and audience revealing that whilst there has been considerable improvements of recent times, the opportunities for new initiatives still exists.

Early in the year, the Branch invited Mr. Peter Loof, ACT member of the National Executive and a member of the Australian Delegation to the Sixth U.N. Conference on Crime Prevention and the Treatment of Offenders held in Caracas in 1980 to address the Branch on this Conference. Owing to other commitments, Mr. Loof has not yet been available to attend Sydney. The Branch is also presently having discussions with a view to presenting a Seminar for members in October 1981 on criminal aspects of the disabled people. Members have continued to support the Sydney University Institute of Criminology Seminars held four times a year.

Apart from the Seminar, your Branch has participated in lengthy discussions this year on improving the service to ex-offenders upon their release from custody. With other concerned agencies, this Branch has been invited to a number of meetings convened by the Director of the NSW Bureau of Crime Statistics and Research. Although a proposal to form a new coordinating association of after care agencies has been rejected by this Branch, because the proposed new body has objectives identical with A.C.P.C., the difficulties expressed by the various agencies are anxieties for which the Branch is concerned, and has offered to assist.

On 11th December, 1980, the Branch held its most enjoyable and traditional Christmas Cocktail Party for members.

The Crime Prevention Week Committee under Mr. J. Parnell S.M. despite approaching the community, the Police and other Departments has so far been unable to obtain the necessary financial and manpower support essential to mount an effective campaign.

The Branch has expressed its full support to the twelve Resolutions passed at the International Prisoners Aid Associations meeting held in Adelaide from 9-12 September 1980.

Following the recent unauthorised departure from Australia of a migrant capital offender released on parole, concern was expressed by certain members. As a consequence discussions are being held with the Parole Board with a view to offering helpful suggestions on this aspect.

The proposal to update the State Branch Constitution is to be considered by the Branch at the next meeting to be held on 20th August 1981. Suggested alterations have been received from Mrs. M. North, the Review Committee Chairman, and distributed to Committee members. Additional copies are available on request to the Secretary.

Records of the Branch have now been located in facilities made available by the N.S.W. Bureau of Crime Statistics & Research. The Branch expresses its gratitude to Dr. J. Sutton, the Bureau's Director for his assistance.

The Executive Committee held ten meetings last year to which Branch members were invited. There have been non-Executive Members at each meeting. The presence and contribution of these members has been welcomed by the Committee. During the year, Mr. R. O'Brien was appointed Assistant Secretary.

It is with sadness that we record the death last year of a dedicated and generous member, the late Arthur Tyler, a former Stipendiary Magistrate and a long serving representative and member of the Association of Civil Rehabilitation Committees of N.S.W.

The Branch expresses its gratitude to all who gave its support and assistance during the past year, and in particular, to our Patron, the Hon. F.D. Walker LL.M., M.P., Attorney General for N.S.W., Mr. T. Haines, Under Secretary of the Dept. of the Attorney General of Justice, and Mr. M. Bennett, Administrative Officer of the same Department, and to W.D. & H.O. Wills for their donation to the Branch.

At the 1980 Annual meeting, the then President, Mr. Justice J.A. Lee retired and the position of President was accepted by Mr. Justice S. Isaacs. Appreciation was recorded at that meeting for the work performed by Mr. Justice Lee for A.C.P.C. during his term as President.

I also express the personal appreciation of the President Mr. Justice S. Isaacs, and myself as Secretary, for the help and contributions received from all the Branch Executive Committee.

The National Council of A.C.P.C. under its capable Executive Director Mr. J. Purcell, is continuing its operations effectively within financial restraints. Decisions of the Council are well recorded and distributed to Branches. The magazine "forum" is published quarterly and continues to be praised by readers. Articles have included contributions from N.S.W. members. This year, the 11th National Conference of A.C.P.C. will be held. The venue is Canberra, A.C.T.; the theme "Policing a Democracy". All members are welcome and a significant number are expected to attend from this State. The Branch has appointed Mr. A.J. Restuccia and Mrs. N. North as its Branch delegates. A copy of their Report will be available after the Conference.

The National Council is presently undertaking a review of its role and that of the Secretariat, to assess the most effective method of fulfilling the objectives of A.C.P.C., Australia wide, in the 1980s. Whether there be changes or not, at National or State level, the fundamental value of A.C.P.C. to the Community will remain unchallenged even if unfortunately, it appears in the commnity to be often undervalued.

Continuing increases in membership, members active in pinpointing areas for discussion, and for social improvement of the laws, members active in serving the needy and the Branch — these should be our immediate Branch objectives. Through an active, alert, diverse membership A.C.P.C. can be fully valued an enjoyed: through the co-ordination by A.C.P.C., citizens can enjoy better the benefits of our Australian way of life.
