

HEADQUARTERS

On 28 June 1973, a significant event in the history of federal policing in Australia occurred with the opening of Cairns Station. It had a strength of two plainclothes Senior Constables.

The significance of the event was that this was the first deployment of Commonwealth Police outside of mainland capital cities.

Thirteen years later, on Wednesday 12 November 1986, another opening took place in Queensland. Northern Region once again took pride and place in the organisation with its second 'first' for federal policing with the opening of the first dedicated and purpose-built Regional Headquarters.

The building was officially opened by Assistant Commissioner R.J. McCabe, BEM, QPM, before distinguished guests representing the Defence Forces, State and Federal Government Departments, the airlining industry, banking fraternity and the Queensland Police, represented by Assistant Commissioner Parker.

The Regional Commander, Chief Superintendent R.H. Gillespie, QPM, said the building was equipped to improve efforts to combat organised crime, drug trafficking and major fraud against the Government. Accordingly, the facilities for the squads have been greatly expanded.

Built at a cost of \$6 million, the new headquarters is on four levels and is equipped with an armoury, gymnasium and a high security vault for drugs and other exhibits. An elaborate and sophisticated security system monitors all floors and access points at all times, centrally monitored from a vastly improved communications centre equipped with the latest electronic and computer equipment.

The building provides a pleasant airconditioned working environment, with accent on natural light permeating the working place. The building is spacious and in many areas there is room for future expansion.

A large recreation room and other facilities have been included and an active social club committee is looking after the social needs of its members.

Members can be justly proud of their new headquarters.

I am writing to place on record my appreciation of the excellent work carried out by a number of your Police Officers in connection with a bad vehicle accident just after midnight on 2 October in McInnes Street, Weston. In brief, a panel van smashed into the wall of my neighbour's garden, spilling the occupants (4 teenagers), some of whom were injured. I phoned for an ambulance and the Police.

The response by your officers was extremely quick. Two cars and a number of officers arrived within minutes and calmly set about their duties, with care for the injured and concern for all involved. I was impressed by their courtesy, efficiency, competence and calming

I have no idea of the identity of all the officers concerned but felt they deserved commendation for exemplary performance of duty and for setting a standard which makes me proud of our Police

My son was involved in a foolish, and I am satisfied one-off, shop stealing incident at Woden Plaza. He was caught and officers from the Woden Station handled the matter.

I am writing to record my appreciation of the courteousness, understanding and what I can best describe as a fine sense of balance displayed by the three officers concerned, Senior Constable Steven Corrigan, First Constable Derek Taws and Sergeant Garry Fulton.

My first knowledge of the incident came when I arrived home to the message that my wife was at the Station. She and the lad arrived home and when I was told that a statement was signed, I could only think of verbaling and all the things that come to the mind of the average person — without foundation and, in the light of my experience, quite incor-

However, I was reassured when my wife could not have spoken more highly of the officers who had brought my son and his friend to the Station. They were considerate and courteous whilst showing the firmness necessary in the circumstances. Later that evening I went to the Station and spoke with Senior Constable Corrigan and some weeks later we both went with my son when he was formally cautioned by Sergeant Fulton.

I decided to write this letter before we knew the outcome, and whilst I hoped that in the circumstances a caution would be given, I was more than satisfied that the approach adopted by the Police had not only earned my respect, but, more importantly, that of my son. They brought home to him not just that what had been done was wrong - he knew this anyway - but what the far-reaching consequences of this type of stupidity can be.

If your officers can do this and earn respect in so doing, they're winning. The community as a whole is fortunate if kids making a wrong step for the first time have the same experience as my son did. The balance was right. Please accept my sincere thanks and appreciation.
