## Farewell Nivison-Smith

TUESDAY November 17 was a day which held little joy for many members of the Australian Federal Police, as Station Sergeant Kevin Nivison-Smith handed in his badge and hung up his cape for the last time.

Kevin retired from the force on grounds of invalidity after a police career spanning 41 years which took him to both sides of the nation.


Station Sergeant Nivison-Smith was born in Narrabri and joined the New South Wales Police as a cadet in 1946.

He served with the NSW force for the next eight years before becoming disenchanted and deciding to try his hand in private enterprise.

However, the memories lingered on and the ties with police work were hard to sever.

So much so, that on December 31, 1959 Kevin was sworn in as a member of the ACT Police Force.

He was attached to the General Duties Branch for about eight months before becoming Commissioner's Clerk, a position he held for the next 18 months.

He spent a further 18 months in the ACT Traffic Branch and then returned to General Duties, City Station.

Kevin was promoted in 1971 enabling him to take up duties as Traffic Adjudication Sergeant for two years. A further promotion to Sergeant First Class resulted in his transfer to Woden Police Station.

In 1979 he moved back to City Station where he remained for a year with Superintendent Prigg until transferring to Western Region in July, 1981.

Upon arrival in Western Australia lhe took up duties as Officer-in-Charge at Perth Airport where he was responsible for the day-to-day running of both the domestic and international terminals.

The Australian Federal Police Station at Perth Airport was the site for a well patronised farewell function.

Kevin's popularity was evidenced by the large gathering of AFP members from Western Region.

In addition the function was attended by airport staff from Customs, the airlines and management representatives from both the Domestic and International Terminals.

The occasion was marked by speeches praising Kevin for his co-operation and dedication to his duties at the airpoint since 1981. Messages of congratulations on a job well done from Deputy Commissioner Johnson (Administration) and other senior officers were read to the gathering.

The acting Regional Commander, Detective Chief Inspector Ken Curnow presented Kevin with a scroll, listing his history of service with the ACT and Australian Federal Police.

In keeping with his hobby, wood carving, Kevin was presented with am electric grinder and wood-carving tools as farewell gifts.
