"I have also been advised that Constable Rugendyke was quite stunned by the revelation that he was to be the recipient of the excellence award. As a dedicated provider of service to others, he had in fact nominated a number of others for the award.

"The thought that he may be nominated never crossed his mind."

Among Constable Rugendyke's contribution to the community has been the initiation of what is now an annual event, the Belconnen Mall Christmas trolley push. The purpose of the trolley push is to collect donations from shoppers and retailers for the distribution to the less fortunate in the community as Christmas gifts.

He is involved with a number of charities that help children, he is a member of the management committee of the Belconnen Youth Centre and he also collects unwanted white goods and arranges delivery to

needy families.

Dave and his wife Barbara are parents to five daughters and recently became grandparents, and still have enough energy and concern remaining that they may be caring for up to six children at any one time.

Dave's police service spans almost 15 years and during that time he has predominantly undertaken community policing through general uniform duties, and some time in the Juvenile Aid Bureau at Belconnen station. In January 1994 he received the Australia Day Medallion as a recognition of his commitment to service.

Since October of last year
Constable Rugendyke has been the
Country Town Police Officer for the
suburb of Kaleen. He was keen to
participate in the trial of Country
Town Policing as he believes that in
addition to law enforcement, police
work also involves that of a social
service nature and he is committed to
fostering a close working relationship
with all groups with in his community.
