The Australian National Commission for UNESCO is sponsoring a National Seminar on Teaching and Research on Human Rights at Tertiary and Adult Education levels to be held in the Faculty of Law of the University of Sydney on 20-22 June, 1980. The Organizing Committee of the Seminar consists of Prof. A.E.-S. Tay, Ms. Dierdre O'Connor of Macquarie University and Mr. Graeme Connelly of the University of New South Wales. Speakers will include Messrs. Peter Bailey and S.I. Benn, Prof. A.R. Blackshield, Senator Gareth Evans, Prof. Agnes Heller, the Hon. Mr. Justice R.M. Hope and Mr. Justice M. Kirby, Professors Lauchlan Chipman, Eugene Kamenka and Julius Kovesi, Dr. J. Kleinig, Professors J. McCloskey, R. Sackville, Peter Singer, Julius Stone, A.E.-S. Tay and C.G. Weeramantry and Mr. E.G.
