

Diplomacy Training Program

The Diplomacy Training Program aims to train peoples of the developing world, in particular the Asia-Pacific region, to better utilise the United Nations and other international forums. It provides a unique introduction to the UN system and its specialised agencies, with training in International Law, Lobbying techniques, Media relations and Regional institutions. It is the only specialist training program for indigenous and minority group representatives available in the world.

The main training session will take place in January each year over a four week period, commencing in 1990. It will involve lectures, discussion, practical examples and role play. A maximum of 45 participants will be registered.

We are informed that the course will be approved for Abstudy purposes. Interested individuals should submit their applications by October 31, stating personal details, academic and professional background and organisational affiliation. A brief statement of the reasons why the applicant wishes to be involved in this program will help the Management Committee make its decisions on attendance.

ALCOHOL AND THE LAW

National Aboriginal and Islander Legal Services Secretariat (NAILSS)

How high are the social costs of alcohol? A burgeoning literature by psychologists, sociologists and social health workers has documented the prevalence and detrimental effects of alcohol use in the community. It is asserted that excessive use of alcohol is not only a specific health problem in itself but contributes to the aggravation of many other medical conditions and causes immense social disruption.

Legal practitioners, the police and the courts are confronted daily with evidence of the consequences of alcohol abuse. How should the law respond to alcohol-related crime and violence, unemployment and poverty, injury and death?

Through the presentation of papers on recent legal developments in Australia and overseas and chairing of discussions, this Seminar aims to examine for the first time ways in which legislators, the police and the courts have dealt with the phenomenon of alcohol abuse and to consider the desirability of developing strategies for sharing responsibility for the provision of appropriate treatment and rehabilitative services. NAILSS invites the participation of legal practitioners, health and social workers, community groups and all those interested in beginning to explore the relationship between law and alcohol.
