FEEDBACK WANTED

Comment is invited on two ideas that may be put before the Aboriginal Law Centre's Management Committee in the near future:

(1) A 2-3 day national conference on the theme "Summary Jurisdiction and Aboriginal Communities".

Is such a conference potentially useful? Should it focus only on the Australian judicial system or should it also consider community justice mechanisms? Who should participate? Magistrates? Police and police aides? Community leaders? Lawyers? How might the principal themes be defined? Where should it be held? When? (2) A suggestion that the Aboriginal Law Centre might establish a "Locums" register of lawyers willing to serve short periods with Aboriginal organizations.

Would such a register be useful? If so, on what sort of occasions? When an organization's own lawyers are on leave? When there is a time lapse before a lawyer can be replaced? When there is a need for temporary help at particularly busy times? When a lawyer is needed for a short term with special skills not normally needed in the organization's usual work?

What are the maximum/minimum periods that such a locum might be useful? What sort of experience might be needed, either in terms of years or expertise?
