## Economics Committee first - Reserve Bank hearing in Wagga Wagga

For the first time since it commenced its twice yearly hearings with the Governor of the Reserve Bank, the House of Representatives Economics Committee will be conducting its Reserve Bank public hearing in regional Australia, away from the financial centres of Sydney and Melbourne. On Friday, 1 December 2000 the House Economics Committee will be meeting with Reserve Bank Governor Ian Macfarlane in Wagga Wagga to discuss the Reserve Bank's semi-annual financial statement. The public hearing will commence at 11am and will be held in the Wagga Wagga City Council Chambers.

"The House Economics Committee has decided to hold this public hearing in Wagga Wagga because we want to emphasise the importance of regional issues for the economic balance sheet of Australia," said David Hawker, House Economics Committee Chair and Member for Wannon (Victoria). "We are giving the Wagga community a valuable opportunity to be a part of this important economic event. At the same time, through other activities associated with the hearing, the Committee and the Reserve Bank Governor will get the chance to meet with regional community representatives and hear from them first-hand about the issues that are of interest and concern to them."
