the wide agreement that in other jurisdictions the adoption of a general system of administrative review had improved the quality of decision-making, and recommended as a matter of priority the adoption of a similar system, to include simplification of the existing complicated judicial remedies, the right to obtain reasons, and a system of review on the merits by an external independent review body.

## Administrative Review Council

On 1 May 1989 the Attorney-General announced the appointment of Mr Stephen Charles QC as a member of the Council for a 3-year term from 27 April 1989. Mr Charles is a senior Victorian barrister and has been a Queen's Counsel since 1975. He was Chairman of the Victorian Bar Council from 1983-85 and President of the Australian Bar Association from 1985-86.

Mr Fulton Muir, Chairman of the Canberra Development Board, who has been a member of the Council since 2 April 1986, was re-appointed for a further 3-year term.

Mr G.A. (Bert) Mowbray, who had been acting Director of Research since 3 April 1989 (<u>Admin Review</u> 20:56), was formally appointed to the position on 25 May 1989.

## Administrative Appeals Tribunal
