CONSTITUTIONAL AWARENESS WEEK

The Constitutional Centenary Foundation has been established to support education and encourage public discussion about the Australian constitutional system during the decade leading up to the centenary of the Australian Constitution in the Year 2001.

As part of its aim to improve awareness, the week of 25-30 March 1996 has been designated Constitutional Awareness Week. During this week activities will include: official opening and citizenship ceremony (where the Governor of Victoria will officiate), debates, displays and other promotional events. A book reviewing citizenship in modernday Australia, with chapters contributed by a number of leading authorities, is also to be published.

LEGAL RIGHTS OF LESBIAN AND GAY COUPLES

The Community Issues Committee of the Young Lawyers' section of the Law Institute of Victoria is seeking comments on the format and contents of a draft pamphlet it has produced dealing with the legal rights of lesbian and gay couples. The pamphlet aims to give an overview of a number of legal issues which affect lesbian and gay couples and to provide helpful information about referral services and available legal resources.

LAW FOUNDATION SERVICE ON INTERNET

The Law Foundation of New South Wales has launched an ambitious program to establish the world's first national legal database on the Internet. Foundation Law will make available on the Internet the full text of Commonwealth, State and Territory legislation and regulations; and decisions of the High Court, Federal Courts and Tribunals, State Supreme Courts, and other State courts.

Foundation Law has been endorsed by the Bar Association of NSW, the

Law Society of NSW and the NSW Attorney-General's Department and has been developed with the co-operation and assistance of the Australasian Legal Information Institute.
