Liquor Industry Initiatives

The Northern Territory's widely -admired Living with Alcohol Program offers the following for the information of members.

In our last article, we mentioned the intersectoral nature of the Living With Alcohol Program (LWA). LWA funds positions in a number of agencies including the NT Liquor Commission, and the liquor industry is one of a number of key target areas for the program.

Wendy Ah Chin is the LWA Aboriginal Community Liaison Officer at the Liquor Commission and is available to discuss with communities issues such as restricted areas, social clubs, liquor permits, and other relevant liquor licensing issues. Wendy can be contacted on (08) 8981 1955.

Jeremy Sorensen is the LWA Community Education and Research Officer at the Liquor Commission, and one of his tasks is to provide licensees across the Territory with up-to-date information about Liquor Licensing issues and alcohol education and training initiatives. Jeremy achieves this via a regular newsletter entitled NTLiquor Action. The latest edition contains information about Derby liquor restrictions, crowd controller inspections, and outcomes from recent Liquor Commission hearings. Some other items from the newsletter are presented here in brief. Extracts from NT Liquor Action, July 1997.

Alcohol Consultative Committee (ACC) - The ACC was formed in formed in 1992 by the then Chief Minister, Marshall Perron, who wished to have the benefit of a committee comprising relevant government departments and representatives of the liquor industry to assist in the development of guidelines to better regulate the liquor industry. The role of the ACC as a provider of advice to government and the Liquor Commission continues to this day - it will play an important role in the review of the Liquor Act, scheduled for completion late 1997.

Yirrkala Restricted Area Permits -About 50% of the larger Aboriginal communities in the Territory are restricted from alcohol by their own request. Under the NT Liquor Act, some of these communities can also arrange to allocate 'permits' to individuals within those communities to allow them to consume alcohol in their own place of residence. The community of Yirrkala earlier this year established a Permit Steering Committee responsible, along with the Police, to make recommendations to the Liquor Commission

on who should or shouldn't be given a permit.

18+ Card - This new 'proof of age' card was launched on 14th May. It is hoped that this card, with support from licensees and retailers, will become widely used by young people in the Territory.

	Showing bright red colours, this starter could prove true that red makes things go faster. Showed redness in face during last run and complained of headaches. A nervous starter.
12	9. Gastritis 6.0
	Reported pains in stomach at last meeting. Sired by 'Ulcers' which used to be a good chance over similar distances to this race. Recent form has shown potential for similar results.
40	11. Good-Memory 5.5
	Seems to have forgotten old magic, distinctly confused at training. Recent form is very inconsistent. Finds it difficult to keep up with improving paces set by less experience opponents.
100	12. Clear-Head 5.0
	Used to perform well in the mornings. Could improve with less alcohol. Needs a reduce handicap and a late start, but not likely to be productive.
50	13. Time-With-The-Kids 5.0
	Outside chance, if more time is spent on home turf - before leaving the stables! Has
