Increased High Court Fees as announced in 1997/ 98 Budget

The Governor General, acting with the advice of the Federal Executive Council, makes the following Regulations under the *Judiciary Act* 1903.

1 Commencement

1.1 These regulations commence on 1 July 1997.

2. Amendment

2.1 The High Court of Australia (Fees) Regulations are amended as set out in these Regulations.

3. Regulation 3 (Interpretation)

3.1 Subregulation 3 (1) (definition of "corporation"). Omit the definition, substitute:

"corporation' has the same meaning as in the Corporations Law and includes a financial institution (as defined in section 111AZA of that Law);"

4. Regulation 5B (Calculation of increase)

4.1 Subregulation 5B (2) (definition of fee): Omit "during", substitute "at the end of".

5. Further amendments - fee increases

5.1 The High Court of Australia (Fees) Regulations are further amended as set out in the following table:
