

Over the last year the Communications Law Centre (CLC) has been looking at the impact of new telecommunications arrangements on services being provided to residential telephone subscribers. The aim of the research is to see what regulatory issues are raised by new services to homes.

This research paper provides a detailed industry profile of audiotex services, more often known as '005' information services, and the forerunner to audiotex, the 'dial-it' services provided on the '11' prefex. It also includes an analysis of the impact of regulation on these new services and proposes innovative principles for regulating new services.
