



# The Who's Who of NISC

It's to be a bells and whistles launch next month of the Government's new National Information Services Council - the body which will scrutinise and discuss the broad policy issues associated with the information superhighway in Australia. Paul Keating himself will chair at least the first meeting of NISC in what is likely to be a highlight of Canberra's political calendar for August.

The cynics will see it as a pre-election effort on Keating's part to show his willingness to consult widely with industry and interest groups before implementing recommendations arising from the Broadband Services Expert Group.

According to the PM's own media machine, NISC will be an important

source of non-government views on key issues and will be a measure of the Government's 'commitment to the notion that we can harness the enormous potential of the information age to achieve a fairer, healthier, better educated and more productive society.'

With such a weighty agenda, it is interesting to note that there are only two meetings scheduled for NISC - one in August and one in October.

The first meeting will look at community access, the evolution of communications services and technologies, industry development, legal and community standards, and the international context and implications of new communications services and technologies. So far, no mention of

big issues like Australian ownership of the superhighway's infrastructure.

A strong emphasis in all the Government statements on NISC is on the need to keep up with the latest marketplace developments. This may explain the abundance of industry people on the Council. Half of the panel of 20 comes from the media and IT industries and of those, five are from the computer hardware industry. It would seem from this that content issues are to take a back seat to technology issues.

NISC is part of a government machine that will eventually come up with a 'National Strategy'. The panel is made up of the following people:

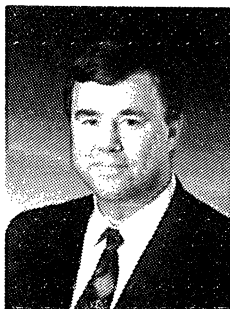


ecomunications research, including computer communications. He was a member of the Broadband Services Expert Group.

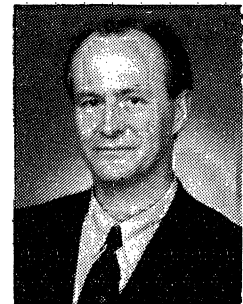
**Brian Johns, AO**

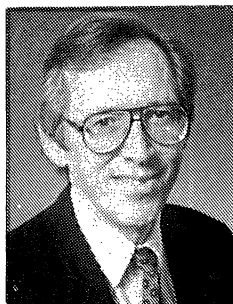
