CAMLA had a very good year for events in 1997. We began in April with a lively twilight seminar on Australia's future on line, at which the speaker was Clem Doherty. In May, we held another twilight seminar on film, television, the budget and the future, at which the speakers were John Morris from the AFC, film producer Tristram Miall and Maureen Barron from Southern Star Group.
