**Lee Ann Bassler** is an Associate Professor of Law at La Trobe University, Australia and an Adjunct Professor in the Graduate program in Critical Disability Studies at York University, Canada. She has researched, written and taught extensively in the areas of children's rights, disability rights and law, and medico-legal issues and has been actively engaged in policy development in the field of disability in Australia and internationally. Lee Ann is co-editor of *Disability, Divers-ability and Legal Change* (Martinus Nijhoff, 1999); *Explorations on Law and Disability in Australia* (Federation Press, 2000); and *Children on the Agenda: The Rights of Australia's Children* (Prospect Media, 2001). **Belinda Bennett** is Professor of Health and Medical Law at the Faculty of Law, University of Sydney. She is Director of the Faculty's Centre for Health Governance, Law and Ethics, and deputy editor of the *Journal of Law and Medicine*. Her research interests include health law and globalisation, legal regulation of new technologies in health care, and legal issues relating to women's health. Her recent publications include *Globalization and Health: Challenges for Health Law and Bioethics* (co-edited with George Tomossy, Springer, 2006) and *Health Law's Kaleidoscope: Health Law Rights in a Global Age* (Ashgate Publishing, 2008). Belinda's current research includes a comparative project (with Isabel Karpin) on legal regulation of preimplantation genetic diagnosis, and an Australian Research Council-funded project (with Wendy Rogers and Isabel Karpin) on the inclusion of women in health research.

**Charles L Bosk** is a Professor and Graduate Chair of sociology, a Senior Fellow of The Leonard Davis Institute for Health Services Research, a Professor in the Department of Medical Sociology at the University of Pennsylvania and an elected Fellow of

the Hastings Center. He is author of *Forgive and Remember: Managing Medical Failure* (University of Chicago Press, 1979/2003) and *All God's Mistakes: Genetic Counseling in a Pediatric Hospital* (University of Chicago Press, 1992). His latest book, *What Would You Do? The Collision of Ethics and Ethnography*, will be published by University of Chicago Press in 2008. His research interests include medical mistakes, misconduct, and the culture of patient safety; genetics; medical education; and research ethics. **Terry Carney** LLB (Hons), Dip Crim (Melbourne), PhD (Monash) is Professor of Law and Director of Research at the Faculty of Law, University of Sydney. The immediate past President of the International Academy of Law and Mental Health, he chaired Commonwealth bodies such as the National Advisory Council on Social Welfare and of the Board of the Institute of Family Studies, along with various State enquiries on child welfare, adult guardianship and health law. The author of a dozen books/monographs and over 100 academic papers, his most recent books include *Managing Anorexia Nervosa: Clinical, Legal & Social Perspectives on Involuntary Treatment* (Nova Science, 2006) and *Social Security Law and Policy* (Federation Press, 2006). He is currently working on an Australian Research Council-funded Linkage study of Mental Health Tribunals to assess the way they balance fairness, freedom, protection and rights to treatment.

**Raymond G De Vries** PhD is a member of the Bioethics Program, the Department of Obstetrics and Gynecology, and the Department of Medical Education at the Medical School, University of Michigan. His recent work includes a monograph, *A Pleasing Birth: Midwifery and Maternity Care in the Netherlands*, (Temple University Press, 2005) which looks at the policies and the science that support the unique maternity care system of the Netherlands, and *The View from Here: Bioethics and the Social Sciences* (Blackwell, 2007) – an edited collection that examines the interdisciplinary project of bioethics. With funding provided by the National Library of Medicine (USA), Raymond is writing a critical social history of bioethics; he is also collaborating on an

**Ian Freckelton** SC is a barrister in full-time practice in Melbourne, specialising at both trial and appellate level in administrative law, medico-legal cases and criminal law. He has been a member of Victoria's Medical Practitioners Board, Psychologists Registration Board, Psychosurgery Review Board, Mental Health Review Board, Disciplinary Appeals Board, Investigation Review Panel, Suitability Panel and Northern Football League Disciplinary Tribunal. He is the founding editor of the *Journal of Law and Medicine* and is the Editor-in-Chief of the journal, *Psychiatry, Psychology and Law*. Ian has written more than 350 peer-reviewed articles and chapters of books and is the author and editor of some 35 books on medical law, mental health law, therapeutic jurisprudence, disciplinary law, criminal injuries compensation, policing, criminal law, expert evidence, causation in law and medicine, and coronial law.

**David Healy** is a Professor of Psychiatry at Cardiff University. He studied medicine at University College Dublin, Ireland, and at Cambridge University. He is a former Secretary of the British

Association for Psychopharmacology, and author of over 150 peer-reviewed articles, 200 other pieces and 20 books, including *The Antidepressant Era* (Harvard University Press, 1997), *The Creation of Psychopharmacology* (Harvard University Press, 2002), *The Psychopharmacologists Volumes 1-3* (Arnold, 2000), *Let Them Eat Prozac* (New York University Press, 2004) and *Mania* (John Hopkins University Press, 2008). His main areas of research are clinical trials in psychopharmacology, and the history of psychopharmacology. David has been involved as an expert witness in homicide and suicide trials involving psychotropic drugs, and in bringing problems with these drugs to the attention of American and British regulators, as well as raising awareness of how pharmaceutical companies sell drugs by marketing diseases and co-opting academic opinion-leaders, ghost-writing their articles.

**Margaret Otlowski** is a Professor at the Faculty of Law, University of Tasmania and Deputy Director of the Centre for Law and Genetics. Margaret has longstanding experience in health law and bioethics through publications, consultancies, including for the former National Bioethics Consultative Committee, the Australian Law Reform Commission (in connection with its joint inquiry with the Australian Health Ethics Committee into the protection of human genetic information) and currently for the National Health and Medical Research Council, and serving on various Tribunals and Committees including the Tasmanian Anti-Discrimination Tribunal and as Chair of the University of Tasmania and later State Human Research Ethics Committee. She is also a member of the Federal Privacy Commissioner's "Health Leaders Forum" and of the Advisory Board for the Australian Twin Registry. She has been involved as Chief Investigator on a number of Australian Research Council-funded collaborative research projects run through the Centre for Law and Genetics where her work has focused on issues of regulation, privacy and discrimination.

**Patricia Peppin** BA (Hons), MA, LLB is Professor of Law at Queen's University in Kingston, Canada, with a cross-appointment to the Department of Family Medicine. She is Director of the Law program in the undergraduate curriculum in the School of Medicine and has been Chair of the Developmental Consulting Program, a multidisciplinary group working primarily in the area of intellectual disabilities. She teaches Health Law, Tort Law, and Drug and Biotechnology Law in the Faculty of Law. Her research focuses primarily on drug advertising and its impact on health and equity, drug safety, gender equity in health law, and mental disability.

**Wendy A Rogers** PhD, FRACGP is Associate Professor of Medical Ethics and Health Law at Flinders University, Adelaide, where she leads the ethics, law and professionalism program in the School of Medicine. Her main research interests include feminist health care ethics, research ethics, and public health ethics. She has published numerous articles and book chapters,

Her work addresses such questions as who is a person, what constitutes killing and is it always wrong, what do we mean by autonomy (and who possesses it), what constitutes sufficient risk and/or harm to warrant criminalisation. She is currently involved in several projects in the areas of disability, late-term abortion and end-of-life decision making.
