**Patrick Keane** was appointed to the High Court in March 2013. At the time of his appointment he was Chief Justice of the Federal Court of Australia. He served as a judge of the Court of Appeal, Supreme Court of Queensland from 2005-2010 before joining the Federal Court. He is a graduate of the University of Queensland and Oxford University. He was admitted to the Queensland Bar in 1977 and in 1988 he was appointed Queen's Counsel. He was Solicitor-General for Queensland from 1992 to 2005.

**Geoffrey Kennett** SC (BA (Hons), LLB (Hons), M Pub Law (ANU), LLM (Syd)) was a legal adviser in the Commonwealth Attorney-General's Department and Counsel Assisting the Solicitor-General before commencing practice as a barrister in 1998. He was appointed Senior Counsel in 2010. He practises mainly in the areas of constitutional and administrative law. He holds Honours degrees in arts and law, and a Masters in Public Law from the Australian National University, and an LLM from Sydney University.
