One exciting element of the Plan is the intention to hold the 2005 National Conference in Canberra between 13 - 16 July 2005. In this issue, there are several updates from new sub-editors including a post election policy outlook from Elizabeth Marsden, Queensland news from Chris McGrath and a very welcome resumption of news from Tasmania by Tom Baxter.

This issue also includes an informative paper on third party rights by Justice Stuart Morris of the Victorian Civil and Administrative Appeals Tribunal, which presents a personal and entertaining perspective of developments in this area. There is also an in-depth examination of the Greentrees decision by Matthew Baird, which identifies important issues for landownership within Ramsar-listed wetlands. Our third article is written by two ecologists, Simon Mustoe and Rohan Clarke, who have described some of the issues surrounding management burning of mallee vegetation and a proposed toxic waste facility in north west Victoria, which may impact upon a listed threatened species, the Mallee Emu-wren.
