Failure to give way in a motor accident case

Robert Harris & Co seeks the assistance of APLA members in a most difficult accident case.

Our client is a young girl from a regional town with a population of approximately 80,000. The girl finished work as a barmaid at 10pm and was travelling home by car at 10.15pm. One block from where she worked, she approached and entered an intersection which was not governed by any form of traffic control. The intersection is one through which heavy trucks regularly travel, as a major transport depot is stationed a short distance away. To the great misfortune of our client, a petrol tanker was travelling through the intersection at the same time she was, and as a result it collided with her vehicle. Subsequently, our client suffered serious head injuries.

At first glance the case seems hopeless, as our client has been breached for failing to give way. However, an engineer and myself approached the same intersection to investigate, and in a period of less than two minutes, two large trucks thundered down from the same direction as the petrol tanker.

Although it looked like a normal intersection in a sprawling network of streets, in fact this intersection was like a highway for heavy vehicles destined for the transport depot.

The engineer and I noticed that immediately after the accident, a "give way" sign had been placed at the intersection and a new white dotted line had been painted on the road. These are now a more clear indication that a driver approaching from the same street as our client did must give way (other than the simple give way to the right rule). These also now indicate where the intersection actually starts.

While we were there, we witnessed a car do exactly what out client did: in fact the driver pulled right out in to the intersection so that he could see left and right. The problem is that there is a large hotel right on the corner of the intersection, to the right, so that drivers approaching from

this street are obscured from seeing the heavy vehicles that thunder down, what is in effect, something of a highway.

Stevens Johnsons Syndrome

We are acting for a client who has a potential claim for damages against a medical practitioner in relation to treatment given. Our client's condition continued to deteriorate and she was admitted to hospital and was diagnosed as having "Stevens Johnsons Syndrome". As a result of this condition and its severity, our client now requires her parents to take care of her on a full-time basis.

CSIRO

We act for a widow of a long-time employee of the CSIRO.

It would appear that the deceased for at least part of his work life with the CSIRO was engaged in laboratory duties which required him to use low level radiation measuring instruments and also possibly to inject low levels of radiation into vegetation.

The deceased died of leukaemia and our client has some beliefs that the leukaemia may well have arisen from the use of those low level radiation measuring instruments, particularly as a fellow employee of the deceased also apparently died of leukaemia shortly beforehand.

From scientific literature and reports in our possession it would appear that there has been considerable debate over recent years as to whether or not exposure to low levels of radiation can be a possesse cause of carcinomas and leukaemias.

Bicycle helmets



I am a solicitor in the UK representing a 47 year-old man who has suffered a severe head injury as a result of a road traffic accident which occurred on 7 July 1996. He was riding a push-bike along a country lane, when he was involved in a collision with a motor car. Primary liability for the accident is not disputed. However, the third party's insurers are alleging contributory negligence on the part of my client due to his failure to wear a helmet.

I am in the process of obtaining expert evidence on this issue. In the UK there is no decided authority on this point although I understand a number of cases are pending before the Court.

I am sure that I have read somewhere that in certain states of Australia it is compulsory to wear a cycle helmet and accordingly there may well be decided cases relating to contributory negligence within that jurisdiction. ■
