SCHOOL LIBRARIES SECTION (NSW GROUP)

Selling the school library at DuĎbo

August 6 saw the School Libraries Section trying something new - taking a professional development day 'on the road'. Our inservice activities are usually held in Sydney, but often up to 20% of the teacherlibrarians attending have travelled halfway across the state to get there. This time we decided to travel out to a location which was central for many T/Ls but far enough away from Sydney for it to have been impractical for most to travel there. Dubbo, and the Orana Education Centre seemed ideal.

The topic, 'Selling the Library – Public Relations for the Teacher-Librarian', was a development of a similar inservice day early last year in Sydney.

Organisation was done jointly in Sydney and Dubbo, with the School Libraries Section greatly assisted by the local T/Ls group led by Zel Turrell (Dubbo South High), with funding from the NSW State Development Committee

For the day itself, 8 committee members went to Dubbo to lead workshops, contrib-ute, and assist with organisation. Two lecturers were flown from Sydney as major speakers.

To describe the 60 participants as 'local' would be misleading with people attending from Wilcannia, Cowra, Hay, Lithgow, Murrumburra, Coonabarabran, Singleton and Brewarrina, but the strong representation from Orana region included primary and secondary government and non-government schools as well as the Municipal and Regional libraries.

Crystal Condous (Kuring-gai CAE) spoke on the application of marketing techniques to 'selling the library' to students, school administrators, other teachers, and beyond. John Lee (Head Librarian, St John's-McKillop School, Lakemba) dealt with the use of A/V and print techniques to inform staff and students about (and entice to) the library. Jennifer Davoren (Division of Services) communicated very effectively the art of communicating. In addition, there were a number of short workshop sessions to take the ideas a stage further to see how they might be implemented in the participants' particular circumstances.

In addition, a new publication, Graphics for Teacher-Librarians, with artwork by Dallas Rivers and Chris Harriott, was launched and proved instantly popular and useful as a graphics aid to 'selling the library

The consensus was that it had been a valuable day, the western librarians showing characteristic enthusiasm and appreciation of the efforts of the Committee and organisers. All that remains now is to decide when. where and on what the next one will be, but there certainly WILL be a 'next one' Graham Spindler.




Joint Branch Council Meeting

sectional groups, a sub-committee of Branch comprising sectional representatives and chaired by Keith Davison forwarded a report to Susan Acutt. Some of the points aised were that:

- (1) Sectional groups should continue to be funded by Branch Councils;
- Lack of representation of national sections on General Council poses a difficulty; and
- (3) Clearer channels of communication need to be established between Sections and Sectional Groups.

Education Department — Central Cataloguing Service

The deplorable situation which has developed in the Education Department's Central Cataloguing Service due to non-replacement of staff was brought to Branch's attention by the School Libraries Sectional Group, and at their instigation the ASLA represenatives on Branch, Richard Gubbins, was asked to comment on this matter. Richard prepared a draft letter to the Minister for Education, to be sent over the Branch Presilent's signature, which included a request or a delegation from Branch to discuss this matter with the Minister.

School/community library study

A sub-committee of Branch convened by Bea Fincher combined with Doug Down, President of ASLA, in preparing a report on he newly released School/Community Libraries in Australia: Report to the Commonwealth Schools Commission Canberra, 1983.

This report was critical, finding the study to be largely descriptive rather than evaluative. Although the document aims to help hose involved in planning/managing jointuse facilities, the descriptive summaries of existing situations are unable to provide the necessary guidelines. The report was presented to the July meeting of General Council and subsequently forwarded to the Schools Commission.

Branch Council Records

Members might be interested to know that he La Trobe Library holds complete sets of Branch Council agendas, minutes and mempers records from 1937-1977. Branch needs to establish a policy on how long records should be held by the Secretary before passng them on to the La Trobe Library.

LAA Handbook

The Publications Board of the LAA is reviewing the format and content of the Association's Handbook and membership directory.

The Board invites members and others who use the Handbook to notify the Association of any changes they feel might be made in the content, format and any other relevant features of this publication.

THE JAMES COOK BICENTENARY SCHOLARSHIP A Travelling Scholarship For Australian and New Zealand Librarians

The Scholarship was established in 1970 and the first award was made in that same 1. year. Subsequent awards will be made every second year thereafter. Tenure of the Scholarship will normally coincide with the academic year in Great Britain, and an amount of £10,250 for a single or £11,500 for a married scholar will be awarded for 1984/85. The value of the scholarship is not negotiable.

2. The scholarship is intended to provide an opportunity for middle ranking Australian and New Zealand librarians to further their professional interests and to study specialized aspects of librarianship either in a work situation or at an approved institution of higher education. Scholars enrolling for courses should normally complete their course within 12-13 months; therefore enrolment for PhD courses requiring a longer period of study is not encouraged.

3. Applicants must be Australian or New Zealand citizens of at least five years standing: they must normally be graduates of a recognized university and hold professional qualifications that entitle them to be on the professional register of the LAA, or the NZLA: they should normally be under 35 years of age.

The successful applicant is not permitted to engage in gainful employment during the 4. tenure of the scholarship.

5. The scholarship will be awarded by a committee consisting of Harrison Bryan, National Library of Australia, Margaret Cameron of Deakin University, Geelong, F.D.O. Fielding, University of Queensland, Peter Durey of Auckland University, New Zealand, and Miles Blackwell of B.H. Blackwell Ltd.

6. Those interested must apply in writing by the date specified, giving these particulars: their name, age, sex, marital status; academic and professional qualifications; professional status and experience (with enough detail to allow the committee to form some judgement), and proposed activities if successful in their application. They must show a certificate of good health and possess a valid passport.

The scholarship will be granted once only to any person and the donors reserve the right 7. not to make an award if there is no suitable applicant.

8. In assessing the suitability of an applicant, the Selection Committee will take into account the age of the applicant, academic and professional attainments, professional experience in librarianship, and published contributions to the literature of librarianship in its widest sense.

The decision of the Selection Committee will be final and no appeals will be heard. 9

10 The successful applicant is expected to return to Australia or New Zealand and to bring expanded knowledge and experience to bear on problems and issues of librarianship in those countries. A report of about 4-5000 words on the study or work experience during the tenure of the scholarship must be presented to the Secretary within three months of return.

11. Applications in quadruplicate must reach the Secretary of the Selection Committee Mr. D.H. Borchardt, P.O. Box 9, North Balwyn, Vic. 3104 not later than 1 November 1983.

The successful applicant will be advised early in 1984. 12.
