No library is an island

IFLA's Standing Committee on Information Technology met in Munich last August. Circumstances conspired to prevent the LAA's representative from attending, but a summary of the meeting, derived from the minutes and papers, may be of interest to members.

The Standing Committee's brief is "to study the development, management, operation and economic viability of modern data-handling systems for libraries and information services, including networks of same, and summarise the state of the art through verbal and written presentations." Through IFLA, the LAA plugs into the world scene.

The Committee considered a wide range of issues related to the creation, dissemination and regulation of information in electronic form. This is how the implications of "information technology" are tackled at international level.

Image storage (videodisc), transborder dataflow (communicating information beyond national borders), microprocessing (library and domestic use of personal computers), Universal Availability of Publications (access to electronic information), electronic publishing (publishing without paper), MARC (multifarious activities related to cataloguing), and national standards for information technology in general, and videotex, were all analysed and reported on over the two days of the meeting.

Hardly surprising then that the main official outcome of the meeting will be commissioning and analysing further studies and reports. Increased awareness of the characteristics of electronic information was the reason for the meeting and is the point of this report.

For those interested, this reporter has a set of the meeting papers, plus further abstracts and papers from an IFLA-sponsored two day seminar on the impact of technology on libraries. No tyranny of distance here. All the IFLA material is relevant to the LAA's introspection on the one hand, and to our own uncertainty about our future work on the other. No wonder that IFLA's 1984 Nairobi conference will take as its theme the indispensability of library and information services in national development, and their consequent claims to financial recognition.

- (3) Copy to be included – determined by Publications Officer in line with objectives of LAA. If there is competition for space, priorities are made in consultation with Executive Director. Directives may be given from General Council and Executive Committee.
- (4) Sources of copy – authenticity and accuracy are taken as given unless there is reason to doubt them.
- (5) Letters – Letters are published if they are topical, of interest to the members and there is space.
- (6) Inserts – Must be booked. A charge is made, divisions pay half-price only. Notices – Divisions: Policy is established by Council. Happenings – Divisions: Free of charge. Non-LAA bodies: Charge is made.
- (7) Advertising – Divisions: Are charged for typesetting and display work only. Other: Actively sought. Charges for typesetting and space are set by Executive Director and Publications Officer in consultation with General Treasurer.

INCITE EDITORIAL POLICY

InCite has now almost completed its fourth successful year of operation. The birth of *InCite* followed a survey of readers of *ALJ* and the subsequent presentation of a report to Council by the *ALJ* Editorial Board on the issue of the format of the *Journal*. The recommendations were:

- (1) four issues of *ALJ* per year
- (2) fortnightly newsletter (later named *InCite*).

The *ALJ* Editorial Board is responsible for the content of the *Journal* and the Publications Officer and Executive Director for the newsletter, incorporating announcements, reports, job advertisements, *The Source*, resident's column, news.

InCite is the basic communication medium for informing members of the activities of the Association, with short news items on developments in librarianship. Members and divisions of the Association are encouraged to submit items for inclusion in *InCite*; however it is not always possible to include all items due to size and other priorities. Reports of the major committees of the Association (General Council, Board of Education, Executive Committee) may take priority over other items.

From time to time some criticisms are made because some items have not been included in *InCite*; there has been some discussion over procedures concerning letters to the editor, and factual errors. At the July meeting of General Council an *InCite* editorial policy was passed; this consists mainly of procedures and is reprinted for the information of members. The terms of reference for the Publications Board include: 'Formulate for approval and oversee the general policy of the Association's newsletter *InCite* and liaise with the Executive Director or make recommendations to the Executive Committee of General Council or to General Council itself as appropriate.'

- (1) Size of *InCite* – determined by budget allocation.

Frequency – set by General Council, publishing dates determined by Publications Officer in accordance with postal regulations.

- (2) Annual budget – determined by Gen-
