DIRECTOR-GENERAL

\$65,417 p.a. (plus \$1,900 expenses of office allowance)

Under its Act, the National Library is required to maintain and develop a national collection of library materials, including a comprehensive collection of library material relating to Australia and the Australian people, and to make the collection available in the national interest.

Applications are invited for the position of Director-General. The Government is seeking a man or woman with administrative ability of a very high order, qualified to administer the organisation and particularly to lead, plan and manage major programs in national library and information activities, services and networks involving increasing international collaboration. The Library has a staff of 665 and an annual budget of \$25 million; its revenue from services is about \$3 million.

The National Library is an independent statutory authority. Its affairs are conducted by a Council of 12 members, of which the Director-General is the executive member. The Director-General has the powers of a Department Head in the Australian Public Service. The Director-General provides high level policy advice to the National Library Council and acts as the Government's senior adviser on library and related information services.

The Director-General is required to manage the organisation with full regard to efficiency and economy, to keep abreast of developments of new ideas, to maintain liaison with leaders in relevant bodies and similar institutions in Australia and abroad, and to bring forward proposals to meet the needs of the future. The position calls for imagination, initiative, vigour and constructiveness of a high order.

In the first instance, appointment will be for a term of up to 7 years, from 28 July 1985, or as soon as possible after this date. The salary is subject to annual review by the Remuneration Tribunal. Superannuation benefits for eligible applicants and other conditions including removal expenses and Public Service leave entitlements will be available.

AUDIOVISUAL SERVICES COMMITTEE

The Audiovisual Services Committee of the LAA held a meeting in Sydney on 29 June 1984.

The committee is currently involved in developing a *Researcher's guide to audiovisual resources* in Australian libraries. Collections of audiovisual materials in Australian libraries have increased considerably in recent years and many are now being used for research purposes. No comprehensive guide to the materials is available for researchers and that being developed by the Audiovisual Services Committee is intended to meet this need.

The committee is also planning to conduct a workshop on the use of audiovisual materials in research. Among issues the committee is currently investigating are difficulties in the purchase of video cassettes, problems in cataloguing machine readable data files and copyright in nonbook materials.
