Orders for the Austrian poster produced for International Children's Book Day 1985 have not been filled because further deliveries of posters from Austria have not yet arrived. The first delivery of only fifty posters was sold out in February and difficulties with Australia Post have meant that the two subsequent deliveries have not been received. IBBY Australia has not banked cheques which accompanied orders and these will be returned if the posters are not delivered within the next eight weeks. Similarly, money already paid with orders for other IBBY publications will be refunded. IBBY Australia apologises for this confusion.
